May kindly see the letter dated 01.08.2016 (at Flag 'A') of Sri Humayun Rasheed Khan, Addl. District & Sessions Judge, Kaushambi, Attached to classification/Misc. Work in the Hon'ble High Court for inclusion of Degree of Ph.D. and add 'Doctor' before his name in his service records .

In his aforesaid letter Sri Humayun Rasheed Khan has submitted attested copy of degree of Doctor of Philosophy in Law (at Flags 'B') to this court and stated therein that he had submitted Ph.D. Thesis in 2012 and got the Ph.D. awarded in law by A.M.U., Aligarh in 2012 with the permission of the Hon'ble Court. He has requested for inclusion of Ph.D. Degree and add 'Doctor' before his name in his service records .

In this connection, it may be submitted that Sri Humayun Rasheed Khan, Addl. District & Sessions Judge, Kaushambi, has entered in U.P. Nyayik Sewa vide Govt. Notification dated 26.05.2006 (at Flag 'C'). He has completed Degree of Ph.D. in Law from Aligarh Muslim University, Aligarh after joining this service with the permission of Hon'ble High Court vide 14.12.2009 (at Flag 'D').

It is further submitted that appointing authority of Judicial Officers is Government of U.P. The qualification of Ph.D. in Law may be included in the service records of Sri Humayun Rasheed Khan, Addl. District & Sessions Judge, Kaushambi, Attached to classification/Misc. Work in the Hon'ble High Court with the permission of Government of U.P., Lucknow. Therefore, it seems proper that the aforesaid application of Sri Humayun Rasheed Khan, Addl. District & Sessions Judge, Kaushambi, regarding inclusion of Ph.D. Degree and add 'Doctor' before his name in his service records may be sent to Government of U.P. for obtaining necessary orders.

Nyayik Sewa of Sri Humayun Rasheed Khan may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government in the matter?
