May kindly see the letter, placed below at flag 'A' & 'A-I' received from Sri Brahmatej Chaturvedi, Chief Judicial Magistrate, Agra regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Brahmatej Chaturvedi had submitted his movable & immovable property statements for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 through his letter dated 24-07-2015 (flagged 'A'). Thereafter he was asked to furnish some information vide Court's letters dated 03-09-2015 & 04-11-2015 (flagged 'C' & 'C-I').

Now, Sri Brahmatej Chaturvedi has submitted required informations alongwith required through his letter dated 04-12-2015 (flagged 'A-I').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

- (1) In the financial year 2010-11, the income from salary and arrears is Rs.06,32,065/-, and from this amount, Rs.1440/- is deducted against GIS, Rs.56,687/- against NPS, Rs.35,130/- against IT, Rs.21,168/- against LIC, Rs,15,660/- against PLI, Rs.8,000/- against SBI mutual fund, Rs.8,000/- L & T infrastructure bond, Rs.58,488/- against car loan and Rs.12,000/- deposited in his PPF account. The balance of his savings bank account (s) enhanced for Rs.72,143/- (including interest) from its previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.02,88,716/-. Thus, a sum of Rs.3,43,349/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2010-11.
- In the financial year 2011-12, the income from salary and arrears is Rs.13,73,605/-, and from this amount, Rs.1440/- is deducted against GIS, Rs.94,056/- against NPS, Rs.1,84,786/- against IT, Rs.21,168/- against LIC, Rs,15,660/- against PLI Rs.30,463/- against Max Insurance, Rs.58,488/- against car loan and Rs.70,000/- deposited in his PPF

account. The balance of his savings bank account (s) enhanced for Rs.2,17,122/- (including interest) from its previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.06,93,183/-. Thus, a sum of Rs.6,80,422/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years  $\frac{2010-11}{2011-12}$ .

- In the financial year 2012-13, the income from salary and arrears is Rs.10,86,956/-, and from this amount, Rs.4,520/- is deducted against GIS, Rs.98,619/- against IT, Rs.21,168/- against LIC, Rs.15,660/- against PLI Rs.30,463/- against Max Insurance, Rs.20,000/- IDFC bond, Rs.48,000/- against SBI gold bond and Rs.1,00,000/- deposited in his PPF account. As such, total deductions/ repayment/ savings/ investment is Rs.03,38,430/-. The balance of his savings bank account (s) reduced for Rs..01,69,225/- (including interest) from its previous year's balance. Thus, a sum of Rs.9,17,751/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial years 2012-13.
- (4) In the financial year 2013-14, the income from salary and arrears is Rs.10,14,388/-, and from this amount, Rs.4,800/- is deducted against GIS, Rs.69,235/- against NPS, Rs.1,09,961/- against IT, Rs.11,170/- against LIC, Rs.15,660/- against PLI Rs.30,463/- against Max Insurance, Rs.52,500/- against house loan, Rs.48,000/- against SBI gold and Rs.500/- deposited in his PPF account. The balance of his savings bank account (s) enhanced for Rs.26,680/- (including interest) from its previous year's balance. As such, total deductions/ repayment/ savings/ investment is Rs.03,68,969/-. Thus, a sum of Rs.6,45,419/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial years 2013-14.

In this connection it is submitted that Sri Brahmatej Chaturvedi, has already submitted her property statement of the financial year 2009-10 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice Rajesh Dayal Khare the then Administrative Judge, Banda at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2010-11 & 2011-12 in its next

financial year i. e. in 2012-13 up to March 2013. He has submitted the same through letter dated 24-07-2015 and as such, there is delay in submitting the said statements and his property statement for the years 2012-13 & 2013-14 in its next financial year i. e. in 2014-15 up to March 2015. He has submitted the same through letter dated 24-07-2015 and as such, there is delay in submitting the said statements. He has not submitted the aforesaid property statements within due time due to misplacement of certain bank accounts and insurance policies related documents for which he has convey his sincere apology as stated in his letter dated 24-07-2015 (flagged 'A').

May, therefore, if approved, the property statements for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 alongwith letters dated 24-07-2015 and 04-12-2015 (flagged 'A' & 'A-I') of Sri Brahmatej Chaturvedi, Chief Judicial Magistrate, Agra be laid before Hon'ble Mr. Justice Shashi Kant Gupta, Administrative Judge, Agra judgeship for His Lordship's kind perusal and orders?
