May kindly see the letter, placed below at flag 'A-II' and 'A-III' received from Sri Nitish Kumar Rai, Additional Civil Judge (Sr. Div.), Bareilly regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family at the time of entering into Judicial service and financial year 2006-07 & 2007-08, 2008-09 & 2009-10 in the prescribed Proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection it is submitted that earlier Nitish Kumar Rai had submitted the statement of her property acquired/ held at the time of entering into judicial service and financial year 2006-07 & 2007-08, (flagged 'A-III') but he has not disclose the balance amount in his Saving and PPF A/C on the date 31-03-07 and 31-03-08 in column no. 5 and 6 and also not given detail information of GPF, GIS, HRA, IT and other investment of the proforma in the property statement of the financial year 2006-07 & 2007-08. Thereafter, he was asked vide Court's letter dated 24-02-2011 (flagged 'C') to furnish the above information. In the mean time Sri Rai has submitted his movable and immovable property statement of the financial year 2008-09 & 2009-10 through his letter dated 27-09-10 (flagged 'A-II') but he has not given the reply of Court's letter dated 24-02-11. Thereafter he was asked to furnish the required information to the Court as asked vide Court's letter dated <sup>01-10-2012</sup> ~~24-02-2011~~ and also furnish the balance amount in his saving and PPF accounts on the date 31-03-09 and 31-03-10 in column no. 5 and 6 and not given detail information of GPF, GIS, HRA, IT and other investment of the proforma in the property statement of the financial year 2008-09 & 2009-10. (flagged 'C-I')

Now in reply of aforesaid Court's letter he has sent letter (flagged 'A' & 'A-1') alongwith his balance amount in the aforesaid account and detail of income of the financial year financial year 2006-07 & 2007-08, 2008-09 & 2009-10

In this connection it is submitted that the officer concerned has joined the U.P. Judicial service on 21-06-2006.

May, therefore, if approved, the statement at the time of entering into Judicial service and financial year 2006-07 & 2007-08, 2008-09 & 2009-10 along with letter dated 10-01-2013 of Sri Nitish Kumar Rai, Additional Civil Judge (Sr. Div.), Bareilly be laid before Hon'ble Mr. Justice V. K. Shukla, Administrative Judge, Bareilly Judgeship for his Lordship's kind perusal and orders?
