May kindly see the letters, placed below at flag 'A' and 'A-I', received from Sri Nitish Kumar Rai, Additional Chief Judicial Magistrate, Lucknow regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2010-11 and 2011-12 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection it is submitted that earlier, Sri Nitish Kumar Rai has submitted his movable and immovable property statement of the financial year 2010-11 and 2011-12 through his letter dated 21-01-2013 (flagged 'A'). Thereafter he was asked to mentioned the detail information of the plot/flat/house in the proforma of immovable property statement for the financial year 2010-11 and 2011-12 clearly (flagged 'C'). Now, Sri Rai has submitted aforesaid information.

In this connection, it is submitted that as per statement of movable and immovable property for the financial year 2010-11 and 2011-12 and papers/information supplied by the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

(1) In the financial year 2010-11, the income from salary is Rs.09,09,367/- and from this amount, Rs.1440/- is deducted against GIS, Rs.18,682/- against CPF, Rs.62,311/- against Income Tax, Rs.1,07,513/- against policy Premium, Rs.231/- against HRR, Rs.2,26,344/- against repayment of house loan and Rs.90,832/- deposited in his PPF account in this year. As such, total deductions/repayment/savings/ investment is Rs.05,07,353/-. Thus, a sum of Rs.4,02,014/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2010-11.

However, it is pertinent to mention here that the balance of saving bank account (s) of Sri Rai is reduced to Rs.6,186/- against balance of previous year. He has also received a sum of Rs. 77,000/- as ~~house~~rent.

(2) In the financial year 2011-12, the income from salary is Rs.11,87,982/- and from this amount, Rs.3400/- is deducted against GIS, Rs.1,63,700/- against CPF, Rs.1,27,878/- against Income Tax, Rs.22,815/- against LIC Premium, Rs.396/- against HRR, Rs.2,91,126/- against repayment of house loan and Rs.97,871/- deposited in his PPF account in this year. As such, total deductions/repayment/savings/ investment is Rs.07,06,884/-. Thus, a sum of Rs.4,81,008/- was therefore available with him to meet out the household

expenditure of his family consisting of four members in whole of the financial year 2011-12.

However, it is pertinent to mention here that the balance of saving bank account (s) of Sri Rai is reduced to Rs.32,280/- against balance of previous year. He has also received a sum of Rs.1,32,000/- as house rent.

In this connection it is submitted that last time, Sri Nitish Rai had submitted his property statement of the financial year 2009-10 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice V. K. Shukla, the then Administrative Judge, Bareilly on 06-03-2013 at flag 'Z'.

It is further submitted that as per policy/Court's Circular Letter, the officer has to submit his property statement for the year 2010-11 and 2011-12 in its next financial year i. e. in 2012-13 up to March 2013. He has submitted the same through letter dated 21-01-2013 and as such, there no delay in submitting the said statements.

May, therefore, if approved, the property statements for the financial years 2010-11 and 2011-12 alongwith letters dated (flagged 'A', & 'A-I') of Sri Nitish Kumar Rai, Additional Chief Judicial Magistrate, Lucknow be laid before Hon'ble Mr. Justice Arun Tandon, Administrative Judge, Lucknow Judgeship for His Lordship's kind perusal and orders?
