May kindly see the letter at flag 'M', received from Smt. Sandhya Srivastava, Judicial Magistrate, Faizabad, by which she has submitted her revised property statement for the years 2006-07 and 2007-08 properly signed, in the matter of grant of permission to get transferred Maruti Wagon R Car in her name from her husband's name.

In this connection, it is submitted that earlier Smt. Sandhya Srivastava vide her letter dated 29.1.09 (flagged 'A') had requested for grant of permission to get transferred Maruti Wagon R Car in her name from her husband's name and the matter was submitted before Hon'ble Mr. Justice M.I. Mustaga for his Lordship's kind perusal and orders, through a detailed office note dated 23.3.09 (flagged 'Y') with the remark also that the officer has submitted her property statements, but the car has not been shown in the same. His Lordship had been pleased to pass an order dated 26.3.09 to call for an explanation of the officer why the car has not shown in Property statements. The order of His Lordship has been communicated to the officer through Court's letter dated 4.4.09. The officer, in reply of Court's letter dated 4.4.09, had submitted her explanation in the matter that she had not mentioned the car in her property statements 2006-07 & 2007-08 inadvertently. She had also furnished her revised statements for the years, but as the statements of property were unsigned, His Lordship, vide order dated 3.8.09 (flagged 'N'),

had been pleased to order to call for explanation again for the lapse in submitting revised unsigned statements. The order was communicated vide Court's letter dated 28.8.09 (flag 'P').

Now, in reply of Court's letter dated 28.8.09, Smt. Sandhya Srivastava vide her letter dt: 11.12.09 at flap 'M', has submitted her revised Property Statement, properly signed and she has explained that she had submitted the unsigned statement inadvertently and she will take care in future for this.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice M.I. Mustafa for his lordship's kind perusal and order in the matter of grant of permission to get transferred the car in her name from her husband's name?
