May kindly see minutes of Hon'ble Committee dt. 27-07-15 (flagged at 'A') constituted for granting three advance increments to the Judicial Officers of U.P. Nyayik Sewa and U.P.H.J.S who have been selected having LL.M Degree.

In this connection it is pertinent to mention here that aforesaid Hon'ble Committee in its earlier meeting held on 06-04-2015 granted three advance increments to the Judicial Officers of U.P. Nyayik Sewa and U.P.H.J.S subject to verification of their LL.M Degree from concerned University. In compliance of which letters were issued to Registrar of concerned University to get verified attached LL.M Degree with the official record of the University. In reply to which, some of the University has asked for providing prior Demand Draft in lieu of verification of LL.M. Degree.

The aforesaid Hon'ble Committee in its meeting held on 27-07-2015 resolved as follows and the same has been approved by Hon'ble the Chief Justice vide order dt. 07-08-2015:-

"Resolved that the Registrar General may get a Demand Draft prepared as per the information furnished by Admin A-1 Department in favour of concerned University which was required to verify LL.M Degree. It may, thereafter, be provided to Admin A-1 Department for sending it to concerned University."

In view of above resolution of Hon'ble Committee, may if deemed fit and proper, the matter be placed before Ld. Sr. Registrar(Budget), for kind perusal and order to the effect that a copy of this note may be provided to Registrar(Accounts), for necessary compliance and to get prepared Demand Draft of the amount in favour of concerned University mentioned below and thereafter hand over the same to Admin-A-1 Department, for sending it to concerned University-
