- May kindly see the letter, placed below at flags 'A', received from Sri Md. Neyaz Ahmad Ansari, Chief Judicial Magistrate, Lucknow regarding issuance of 'No Objection Certificate' for obtaining Passport.

In his letter, Sri Ansari has stated that he wants to apply for passport. Thus, 'No Objection Certificate' is required from the Hon'ble High Court. He has enclosed four passport size photographs of himself and required 'Affidavit' (flag 'B') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. His dependents are Smt. Shamsha Shahin (Wife), Km. Zara Neyaz & Km. Zubairiya Neyaz (Daughters). He has, therefore, requested for issuance of 'No Objection Certificate' <sup>for obtaining</sup> passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). As per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Md. Neyaz Ahmad Ansari. His request is considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Arun Tandon, Administrative Judge, Lucknow Judgeship, the 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Sri Md. Neyaz Ahmad Ansari, Chief Judicial Magistrate, Lucknow as requested, for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
