May kindly see the letter dated 03.10.2013 of Mohd. Neyaz Ahmad Ansari, Additional Chief Judicial Magistrate, Lucknow duly forwarded by the District Judge, Lucknow regarding inclusion of degree of LL.M. in his service records (at Flag 'A').

It may be recalled that earlier Mohd. Neyaz Ahmad Ansari, Additional Chief Judicial Magistrate, Lucknow sent a letter dated 07.08.2013 (at Flag 'B') alongwith self-attested copy of LL.M. marksheets and stated in his letter that he has completed two years degree of LL.M. from Allahabad University in the year 2003-2004 and joined U.P. Nyayik Sewa as Civil Judge (Jr. Div.), Azamgarh on 15.06.2006 and requested for inclusion of degree of LL.M. in his service records.

Then a court's letter dated 10.09.2013 (at Flag 'C') was sent to District Judge, Lucknow with the request to ask Mohd. Neyaz Ahmad Ansari, Additional Chief Judicial Magistrate, Lucknow to submit attested (not self attested) copies of LL.M. (Ist & IInd year) marksheets and its degree, to this court, so that necessary action may be taken in the matter.

In reply of court's letter dated 10.09.2013, Mohd. Neyaz Ahmad Ansari, Additional Chief Judicial Magistrate, Lucknow through his letter dated 03.10.2013 (at Flag 'A') has submitted attested copy marksheets of LL.M. (Ist & IInd year) and original Provisional Certificate of LL.M., which are at (Flags 'D', 'E', & 'F' respectively) to this court and requested for inclusion of LL.M. in his service records.

In this connection it is submitted that Mohd. Neyaz Ahmad Ansari, Additional Chief Judicial Magistrate, Lucknow has joined U.P. Nyayik Sewa on 15.06.2006 and completed two years degree of LL.M. from "Allahabad University" in the year 2003-2004 and mentioned LL.M. Ist year in the U.P. Nyayik Sewa Form (at Flag 'G').

In this connection, it is submitted that Appointing authority of Judicial Officers of State is Government of U.P. The qualification of LL.M. may be included in the service records of Mohd. Neyaz Ahmad Ansari, Additional Chief Judicial Magistrate, Lucknow with the permission of Government of U.P. as the appointing

authority of Judicial Officers is Government of U.P. Therefore, it seems proper the original provisional certificate of LL.M. and attested copy of marksheets of LL.M. (Ist & IInd year) and attested copy of form of U.P. Nyayik Sewa, regarding inclusion of degree of LL.M. in his service records may be sent to the Government for obtaining necessary orders.

If approved by Hon'ble Mr. Justice Arun Tandon, Administrative Judge, Lucknow, copy of letter dated 03.10.2013 and 07.08.2013 of Mohd. Neyaz Ahmad Ansari, Additional Chief Judicial Magistrate, Lucknow regarding inclusion of LL.M. in his service records, original provisional certificate of LL.M., attested copy of marksheets of LL.M. (Ist & IInd year) and attested copy of form of U.P. Nyayik Sewa of Mohd. Neyaz Ahmad Ansari may be sent to the Joint Secretary, Appointment Section-4, Government of U.P. for obtaining necessary orders of the Government in the matter.
