May kindly see the letter dated 25.6.2015 (at flag 'A') of Sri Rakesh Tripathi, Additional Civil Judge(Sr.Div.), Varanasi by which he has submitted his statements of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13, 2013-14 and 2014-15.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2010-11, Sri Tripathi's gross Salary (i.e. Net Income from Salary + Deductions from Salary) is Rs.10,75,298/- from this amount, he has paid Rs.1440/- against GIS, Rs.1,33,770/- against Income Tax, Rs.62,400/- towards installments of loan, Rs.2,11,611/- against CPF, Rs.30,000/- against PPF, Rs.70,047/- against LIC, Rs.27,500/- against Mutual funds. The balance of his Saving Bank Account(s) enhanced for Rs.4523/-. As such, total deductions /Savings/investment is Rs.5,41,197/-. Thus a sum of Rs.5,34,101/- was therefore available with him to meet out the household expenditure of his family consisting of six members in the financial year 2010-11.

(2) In the statement of movable and immovable property for the financial year 2011-12, Sri Tripathi's gross Salary (i.e. Net Income from Salary + Deductions from Salary) is Rs.10,08,151/- from this amount, he has paid Rs.3120/- against GIS, Rs.98,600/- against Income Tax, Rs.62,400/- towards installments of loan, Rs.73,152/- against CPF, Rs.70,000/- against PPF, Rs.91,396/- against LIC, Rs.70,000/- against Mutual funds. The balance of his Saving Bank Account(s) enhanced for Rs.1,13,690/-. As such, total deductions /Savings/investment is Rs.5,19,958/-. Thus a sum of Rs.4,88,193/- was therefore available with him to meet out the household expenditure of his family consisting of six members in the financial year 2011-12.

(3) In the statement of movable and immovable property for the financial year 2012-13, Sri Tripathi's gross Income from Salary (i.e. Net Income from Salary + Deductions from Salary) is Rs.9,86,446/- from this amount, he has paid Rs.4800/- against GIS, Rs.57,690/- against Income Tax, Rs.3,51,768/- towards installments of loans, Rs.6562/- against CPF, Rs.1,00,000/- against PPF, Rs.91,396/- against Insurances, Rs.72,000/- against Mutual funds. As such, total deductions /Savings/investment is Rs.6,84,216/-. The balance of his Saving Bank Account(s) decreased for Rs.63,453/-. Thus a sum of Rs.3,65,683/- was therefore available with him to meet out the household expenditure of his family consisting of six members in the financial year 2012-13.

(4) In the statement of movable and immovable property for the financial year 2013-14, Sri Tripathi's total income from Salary and other Sources is Rs.13,03,778/- from this amount, he has paid Rs.4800/- against GIS, Rs.1,00,700/- against Income Tax, Rs.2,91,768/- towards House loans installments, Rs.1,29,016/- against CPF, Rs.1,00,000/- against PPF, Rs.91,396/- against Insurances, Rs.72,000/- against Mutual funds. The balance of his Saving Bank Account(s) enhanced for Rs.60,747/-. As such, total deductions /Savings/investment is Rs.8,50,427/-. Thus a sum of

Rs.4,53,351/- was therefore available with him to meet out the household expenditure of his family consisting of six members in the financial year 2013-14.

The property statements for the financial year 2014-15 alongwith property statements for the financial year 2015-16 will be due in the financial year 2016-17 as per Circular letter dated 13.5.04.

The movable and immovable property statement for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 25.6.2015 (flag 'A'). The property statements for the financial years 2010-11 and 2011-12 was due to be submitted in the financial year 2012-13 i.e. on or before 31.3.13. The Property Statements for the financial years 2012-13 and 2013-14 was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is delay in submitting the Property statements for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 from the part of the officer for which officer has stated that due to mistake, he has not submitted his statements in due time for which he has begged pardon.

In this connection, it is submitted that Sri Tripathi has already submitted his property statement upto financial year 2009-10 which was seen by Hon'ble Mr. Justice S.U.Khan, the then Administrative Judge, Jhansi Judgeship on 23.2.2011 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 Sri Rakesh Tripathi, Additional Civil Judge(Sr.Div.), Varanasi may kindly be laid before Hon'ble Mr. Justice Shri Narayan Shukla, Administrative Judge, Varanasi-Judgeship for His Lordship's kind perusal and orders ?
