Request, 118 May kindly see the letters dated 25.6.2015, 1.2.2018 and 15.11.2018 'placed below' (at flag 'A', 'A-1' and 'A-2') received from Sri Rakesh Tripathi, Additional District and Sessions Judge(FTC), Deoria regarding submission of statement of movable property for the financial years 2014-15, 2015-16, 2016-17 and 2017-18.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15, 2015-16, 2016-17 and 2017-18 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

- (1) In the financial year 2014-15, Sri Tripathi total income from Salary and other Sources is Rs.13,03,778/-(i.e. Net Income from Salary is Rs.10,09,262/- + deduction from Salary is Rs.2,34,516/- and income from House Rent is 60,000) from this amount, he has paid Rs.4800/- against GIS, Rs.129016/- against CPF, Rs.1,00,700/- against Income Rs.291,768/- towards installments of loan, Rs.1,00,000/- against PPF, Rs.70,047/- against Insurances, Rs.72,000/- against Mutual fund and 21,349/- against Bajaj Allianz. The balance of Rs.65,904/-. enhanced for Account(s) Bank Saving deductions/Savings/investment is Rs.8,55,584/-. Thus a sum of Rs.4,48,194/- was therefore available with im to meet out the household expenditure of his family consisting of five members in the financial y ears 2014-15.
- (2) In the financial year 2015-16, Sri Tripathi total income from Salary and other Sources is Rs.12,74,804/- (i.e. Net Income from Salary is Rs.9,78,741/- + deduction from Salary is Rs.2,24,063/- and income from House Rent is 72,000) from this amount, he has paid Rs.4800/- against GIS, Rs.1,36,093/- against CPF, Rs.83,170/- against Income Rs.291,768/- towards installments of loan, Rs.1,00,000/- against PPF, Rs.1,01,147/- against Insurances, Rs.72,000/- against Mutual fund and 21,349/- against Bajaj Allianz. As such, total deductions/Savings/investment is Rs.8,10,327/-. The balance of his Saving Bank Account(s) decreased for Rs.13,480/-. Thus a sum of Rs.4,64,477/- was therefore available with im to meet out the household expenditure of his family consisting of five members in the financial y ears 2015-16.
- (3) In the financial year 2016-17, Sri Tripathi total income from Salary and other Sources is Rs.14,08,744/- (i.e. Net Income from Salary is Rs.10,88988/- + deduction from Salary is Rs.2,35,756/- and income from House Rent is Rs.84,000/-) from this amount, he has paid Rs.4800/- against GIS, Rs.1,25,861/- against CPF, Rs.1,05,095/- against Income Tax, Rs.3,49,356/- towards installments of loan, Rs.1,50,000/- against PPF, Rs.1,01,147/- against Insurances. The balance of his Saving Bank Account(s) enhanced for Rs.35,389/-. As such, total deductions/Savings/investment is Rs.8//1,648/-. Thus a sum of Rs.5,37,096/- was therefore available with im to meet out the household expenditure of his family consisting of five members in the financial y ears 2016-17.
- (4) In the financial year 2017-18, Sri Tripathi total income from Salary and other Sources is Rs.15,75,525/- (i.e. Net Income from Salary is Rs.13,79,592/- + deduction from Salary is Rs.2,68524/-, income from House Rent is Rs.96,000/- and Rs.3933/- is from Bank interest) from this amount, he has paid Rs.4800/- against GIS, Rs.1,28,324/- against CPF, Rs.1,35,400/against Income Tax, Rs.3,49,356/- towards installments of loan, Rs.1,00,000/- against PPF, As such, total deductions/Savings/investment is Rs.1,01,147/- against Insurances. Rs.8,19,027/-. The balance of his Saving Bank Account(s) decreased for Rs.17,657/-. Thus a sum of Rs.7,74,155/- was therefore available with im to meet out the household expenditure of

his family consisting of five members in the financial y ears 2017-18.

The movable and immovable property statement for the financial year 2014-15 has been submitted by the officer vide his letter dated 25.6.15(flag 'A'); movable and immovable property statement for the financial year 2015-16 and 2016-17 has been submitted by the officer vide his letter dated 1.2.18 (flag 'A-1') and property statement for the financial year 2017-18 has been submitted by the officer vide his letter dated 15.11.18 (flagged 'A-2'). Property statement for the financial years 2014-15 and 2015-16 was due to be submitted in third financial year 2016-17 i.e. on or before 31.3.17 and property statement for the financial years 2016-17 and 2017-18 was due to be submitted in third financial year 2018-19 i.e. on or before 31.3.19. As such there is delay in submitting the property statement for the financial year 2015-16 from the part of officer for which officer has regretted.

In this connection it is submitted that Sri Tripathi has already been submitted his property statement for the financial year 2013-14 which has been seen by Hon'ble Mr. Justice Shri Narayan Shukla, Administrative Judge, Varanasi which is at flag 'Z'. The said statement is at flag 'M'.
