May kindly see below placed letter dated 31.08.2016 of Sri Rakesh Tripathi, Judge, Small Causes Court, Varanasi duly forwarded by District Judge, Varanasi regarding grant of benefit of three advance increments in view of having post graduate degree in Law at each stage of promotion.

In the aforesaid letter, Sri Tripathi has stated that he had sent a letter No. 1473/I dated 11.07.2016 through District Judge, Varanasi to Principal Secretary, Appointment Section, Govt. of U.P., regarding grant of three advance increments at each stage of promotion. In reply to which he has been informed vide letter dated 324/II-4-2016-26(4)/2016 dated 23.08.2016 (flagged at 'A') to send the same through Registrar General, High Court Allahabad. He has requested to forward his representation to the Govt. of U.P. for further necessary action in this regard.

In this context, it is submitted that Sri Rakesh Tripathi was sanctioned benefit of three advance increments vide this Court letter dated 09.10.2013 (flagged at 'B') with effect from date of joining. As per his representation dated 31.08.2016 (flagged at 'C'), benefit of three advance increments has been granted to him from 16.06.2006 to 14.12.2009. It has been stopped from 14.12.2009 i.e. date of his promotion to Civil Judge (Senior Division) cadre. He has further stated that when he asked to Addl. Director Treasury, Allahabad about it. He was informed that it has included on minimum salary of Senior Division and not granted the benefit of three advance increments separately on promotion to Senior Division.

In this context, it is humbly submitted that in pursuant of order of Hon'ble Chief Justice, issue regarding admissibility of grant of three advance increments to those judicial officers who have already been granted the same benefit, on their future promotional post i.e. promotion to higher scale [Civil Judge(Senior Division)]/ Higher Judicial Service separately or not, has been referred to Govt. of U.P. for clarification vide this Court's letter dated 27.08.2015 (Flagged at 'D') but no reply has been received till date.

Under the fact submitted above, if deemed fit & proper, the file may kindly be laid before Learned Registrar General for kind perusal and order to the effect that aforesaid representation dated 31.08.2016 of Sri Rakesh Tripathi, Judge, Small Causes Courts, Varanasi, alongwith enclosures may be sent to Principal Secretary, Appointment Section-4, Govt. of U.P. for further necessary action in this regard?
