

3 That the departure of the deponent from India may not, or is not likely to be detrimental to the security of India.


That the presence of the deponent outside India may not, or is not likely to prejudice the friendly relations of India with any foreign country.

- 6. That no proceedings in respect of any offence alleged to have been committed by the deponent are pending before a criminal court in India.
- 7. That a warrant or summons for the appearance, or a warrant for the arrest, of the deponent has not been issued by a court under any law for the time being in force or that an order prohibiting the departure from India of the deponent has not been made by any such court.
- 8. That the deponent has not been repatriated.
- 9. That there is no possibility of arising embarrassing position before Government of U.P. due to his visit to any foreign country.
- 10. That issue of 'Identity Certificate' for obtaining a passport was never refused to me.
