May kindly see the letter, placed below at flag 'A' received from Sri Vikas Gupta, Additional Chief Judicial Magistrate, Bareilly regarding issuance of 'No Objection Certificate'/ 'Identity Certificate' for obtaining Passport.

In his letter, Sri Gupta has stated that he is in need of 'Identity Certificate'/'No Objection Certificate' for issuance of passport. He has enclosed four passport size photographs of himself and required 'Affidavits' (flag 'B'&'B-1') in connection with declarations as per G.O. and Section 6 (2) of Passport Rules. His dependents are Smt. Vishakha Gupta (Wife), Sri Ram Chandra Gupta (Father), Master Kartik Gupta & Master Vinayak Gupta (Sons). He has, therefore, requested to issue him 'No Objection Certificate'/ 'Identity Certificate' for obtaining passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). He has requested for the same from the Court. As per reports, placed below, no vigilance/ departmental enquiry is pending against Sri Gupta. His request is considerable, as he has submitted required details and papers in this connection.
