May kindly see the letter placed below at flag 'Z', received from Sri Vikas Gupta, Addl. District Judge/ FTC, Kanpur Nagar, by which he has submit supplementary details/ information/ papers, as asked for vide Court's letter no. 5630/ IV- 3206/ Admin (A) dated 04.04.2018 for grant of permission to visit Singapore, Malaysia and Thailand in summer vacation from 21.06.2018 to 30.06.2018 alongwith his wife and two children to celebrate Golden Jubilee ceremony of his parents-in-law's marriage.

In this connection, it is submitted that Sri Gupta had earlier applied for grant of permission to visit Singapore, Malaysia and Thailand in-summer vacation from 21.06.2018 to 30.06.2018 alongwith his wife and two children to celebrate Golden Jubilee ceremony of his parents-in-law's marriage on the sponsorship of all the expenses i.e Rs. 2,00,000/- (approx.) of the entire trip by his brother-in-law Sri Vishal Mohan Garg, through his letter dated 26.02.2018 (flag 'A') and the same matter was put up before Hon'ble Mr. Justice Pankaj Mithal, Administrative Judge, Kanpur Nagar Judgeship through office note dated 15.03.2018 ( flag 'P'), upon which His Lordship had been pleased to approve the proposal for grant of permission to the officer as requested. Upon submission of the matter to Hon'ble The Chief Justice for confirmation/ approval of the permission, as already permitted/ approved by Hon'ble The Administrative Judge, Kanpur Nagar, it has been directed to the office to ask the officer to file an 'Affidavit' stating the reasons that as to why his brother-in-law Sri Vishal Mohan Garg is ready to spent the money i.e. all the expenses of his proposed abroad trip and also to submit documentary proof of his relationship with Sri Garg. Accordingly, the same details/ papers has been asked from the officer through Court's letter dated 04.04.2018 (flag 'ZZ').

Now, in reply of the Court's letter dated 04.04.2018, Sri Gupta vide his letter dated 23.04.2018 (flag 'Z') has stated that his brother-in-law has sponsored the proposed trip not only for his family but parents and sister of his wife and her family. He has submitted an 'Affidavit' (flag 'Z-1') stating the reasons regarding his brother-in-law Mr. Vishal Mohan Garg spending money for the proposed trip for him and his family members i.e. out of natural love and affection to his sisters and their families and as a mark of respect to his parents on their marriage anniversary, and photocopy of the Passport (flag 'Z-2') of Mr. Vishal Mohan Garg showing common parentage with his (officer's) wife Smt. Vishakha Gupta (copy of her Passport is at flag 'Z-3'), which established that Mr. Vishal Mohan Garg is his real brother-in-law. He has, therefore, again requested to place the matter before the Hon'ble Court for approval.

Under the facts and circumstances mentioned above, if approved, the file
