May kindly see the letters dated 5.3.14 and 2.5.14 (at flag 'A' and 'B') of Sri Vikas Gupta, Additional Chief Judicial Magistrate, Bareilly by which he has submitted his Property statement for the financial years 2010-11, 2011-12, 2012-13 and 2013-14.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the financial year 2010-11, Sri Gupta's total income from Salary and Arrears is Rs.11,32,279/-, from this amount, he has paid Rs.1,10,064/- against Income Tax, Rs.41,627/- against NPS, Rs.1440/- against GIS, Rs.1,09,200/- against Housing, Rs.100/- against PPF, Rs.5362/- against Insurances. The balance of his Saving Bank Account(s) and Cash in hand enhanced for Rs.2,89,998/- this year. As such, total deductions /Savings/investment is Rs.5,57,791/-. Thus a sum of Rs.5,74,488/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2010-11.

(2) In the financial year 2011-12, Sri Gupta's total income from Salary and Arrears is Rs.10,60,353/-, from this amount, he has paid Rs.63,500/- against Income Tax, Rs.77,634/- against NPS, Rs.3960/- against GIS, Rs.1,09,200/- against Housing loan installments, Rs.100/- against PPF, Rs.5362/- against Insurances and Rs.96,000/- against R.D. As such, total deductions /Savings/investment is Rs.3,55,756/-. The balance of his Saving Bank Account(s) and Cash in hand decreased for Rs.3,09,039/- this year. Thus a sum of Rs.10,12,636/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2011-12.

(3) In the financial year 2012-13, Sri Gupta's total income from Salary, Arrears and others is Rs.11,12,672/-, from this amount, he has paid Rs.99,859/- against Income Tax, NPS nil, Rs.4800/- against GIS, Rs.1,09,200/- against Housing loan installments, Rs.1,31,208/- against Vehicle loan, Rs.100/- against PPF, Rs.5362/- against Insurances, Rs.96,000/- against R.D. and the balance of his Saving Bank Account(s) and Cash in hand enhanced for Rs.1,15,078/- this year. As such, total deductions /Savings/investment is Rs.5,61,607/-. Thus a sum of Rs.5,51,065/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2012-13.

(4) In the financial year 2013-14, Sri Gupta's total income from Salary, Maturity amount of RDs and others is Rs.19,31,708/-, from this amount, he has paid Rs.1,00,122/- against Income Tax, Rs.83,231/- against, Rs.4800/- against GIS, Rs.1,09,200/- against Housing loan installments, Rs.1,31,208/- against Vehicle loan Installments, Rs.100/- against PPF, Rs.5362/- against Insurances, Rs.96,000/- against R.D., Rs.8,00,000/- given to his sister. The balance of his Saving Bank Account(s) and Cash in hand enhanced for Rs.39891/- this year. As such, total deductions /Savings/investment is Rs.13,69,914/-. Thus a sum of Rs.5,61,794/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2013-14

The movable and immovable property statement for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 has been submitted by the officer vide his letters dated 5.3.14 and 2.5.14 (flag 'A')^(B) The movable and immovable property statement for the financial years 2010-11, 2011-12 has been submitted by the officer vide his letter dated 5.3.14 (flag 'A') which was due to be submitted in the financial year 2012-13 i.e. on or before 31.3.13 and The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 2.5.14 (flag 'B') which was due to be submitted in the financial year 2014-15 i.e. 31.3.15. As such there is delay in submitting the Property statement for the financial year 2010-11 and 2011-12 from the part of the officer.

In this connection, it is submitted that Sri Gupta already submitted his property statement upto financial year 2009-10 which was seen by Hon'ble Mr. Justice Vimlesh Kumar Shukla, the then Administrative Judge, Agra Judgeship on 10-11-10 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of Sri Vikas Gupta, Additional Chief Judicial Magistrate, Bareilly may kindly be laid before Hon'ble Mr. Justice Krishna Murari, Administrative Judge, Bareilly Judgeship for His Lordship's kind perusal and orders?
