May kindly see the letter dated 15.2.2017 (at flag 'A') of Sri Vikas Gupta, Judge Small Causes Court, Kanpur-Nagar by which he has submitted his Property statement for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

- (1) In the financial year 2014-15, Sri Gupta's total income from Salary and other Sources [is Rs.12,90,249]? (including Encashment of earned leave of Rs. 2,09,271), from this amount, he has paid Rs.28,908/- against Samptuary allowance/ROA, Rs.4800/- against GIS, Rs.91,252/- against Income Tax, Rs.1,70,040/? against DCI, Rs.25,520/- against LIC, Rs.39,312/- aginst PLI, Rs.1,09,200/- towards Housing loan, Rs.1,31,208/- towards Vehicles loan and Rs.37,500/- against PPF. The balance of his Saving Bank Account(s) and Cash in hand enhanced for Rs.1,35,977/- this year against the balance of previous year. As such, total deductions /Savings/investment is Rs.7,73,717/-. Thus a sum of Rs.5,16,532/- was-therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2014-15.
- is Rs.12,23,573/-, from this amount, he has paid Rs.29,695/- against Samptuary allowance/ROA, Rs.4800/- against GIS, Rs.1,16,159/- against Income Tax, Rs.1,60,848/- against DCI, Rs.25,520/- against LIC, Rs.39,312/- aginst PLI, Rs.1,09,200/- towards Housing loan, Rs.1,31,208/- towards Vehicles loan and Rs.1,50,000/- against PPF. As such, total deductions /Savings/investment is Rs.7,66,742/-. The balance of his Saving Bank Account(s) and Cash in hand decreased for Rs.1,29,666/- this year against the balance of previous year. Thus a sum of Rs.5,8449//- was therefore available with him to meet out the household expenditure of his family/ consisting of four members in the financial year 2015-16.

The Income of his Wife Smt. Vishakha Gupta who is running a children school is Rs.2,40,000/- (in the financial year 2014-15) and Rs. 2,70,000/- (in the financial year 2015-16).

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 15.2.2017 (flag 'A') which was due to be submitted in the financial year 2016-17 i.e. on or before 31.3.17. As such there is no delay in submitting the Property statement for the aforesaid periods from the part of the officer.

In this connection, it is submitted that Sri Gupta already submitted his property statement upto financial year 2013-14 which was seen by Hon'ble Mr. Justice Krishna Murari, the then Administrative Judge, Bareilly Judgeship on 20.9.2014 at flag 'Z' and the said statement is at flag 'M'.
