
May kindly see the letters dated 29.3.19 (flagged 'A' ) by which Sri Vikas Gupta, Additional District and Sessions judge(FTC), Kanpur-Nagar has submitted his movable and immovable property statement for the financial years 2016-17 & 2017-18.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2016-17 & 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

> (1) In the financial year 2016-17, Sri Gupta's total income from Salary and other Sources is Rs.23,94,325/- (Rs.11,94,325/- from Salary, Rs.8,00,000/- from the account of his father after his death and Rs.4,00,000/- returned by his sister Smt. Kusum Lata) and total deductions /Savings /investment/repayment DCI, GIS, Income Tax, PPF and LIC, PLI, SIP, Housing loan and FDR (including enhancement in his S.B.A/c of Rs.9085/- this year against the balance of previous year) is Rs.15,86,025/-. Thus a sum of Rs.808300/- + Rs.15,000/- cash in hand was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2016-17. (2) In the financial year 2017-18, Sri Gupta's total income from Salary is Rs.14,81,876/- and total deductions /Savings /investment/repayment against DCI, GIS, Income Tax, PPF and LIC, PLI, SIP, Housing loan is Rs.7,31,067/-. The balance of his S.B. A/c has been decreased of Rs.3437/- this year against the Thus a sum of Rs.7,50,709/- +balance of previous year . Rs.36000/- (cash in hand) was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2017-18.

The movable and immovable property statement for the financial years 2016-17 and 2017-18 has been submitted by the officer vide his letter dated 29.3.19 (flagged 'A' ) which was due to be submitted in third financial years 2018-19. As such there is no delay in submitting the aforesaid statements from the part of officer.

In this connection it is submitted Sri Gupta had already submitted his



property statement upto financial year 2015-16 which had already been seen by Hon'ble Mr. Justice S.N.Shukla, the then Administrative Judge, Kanpur-Nagar Judgeship on 15.9.17, which is at flag 'Z' and the said statement at flag 'M'.
