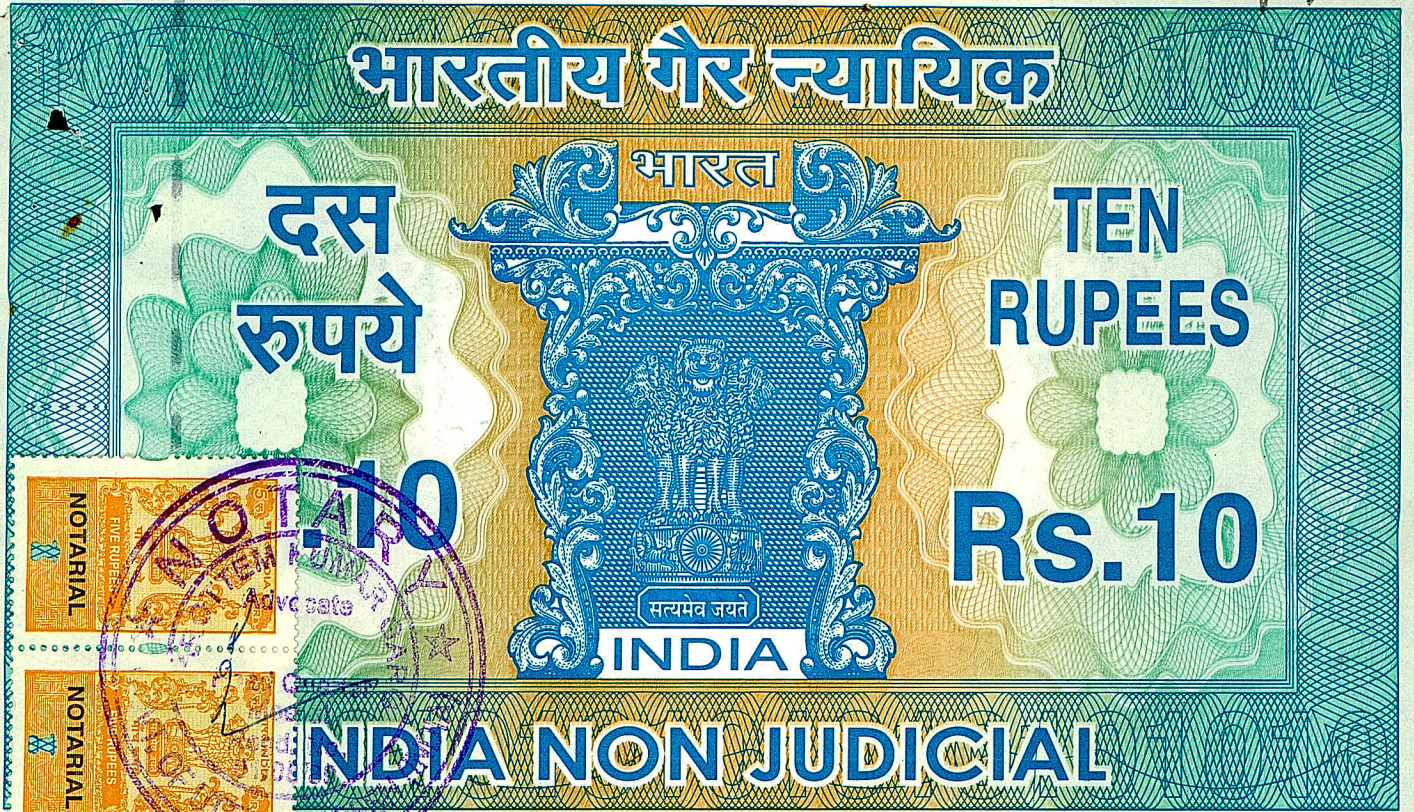

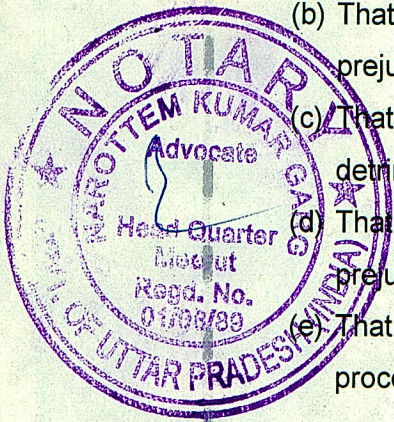

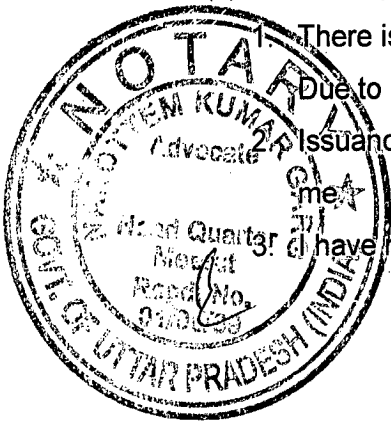
- (f) That proceedings in respect of any alleged to have not been committed by the applicant are not pending before a Criminal Court in India.

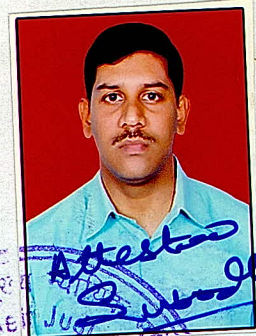

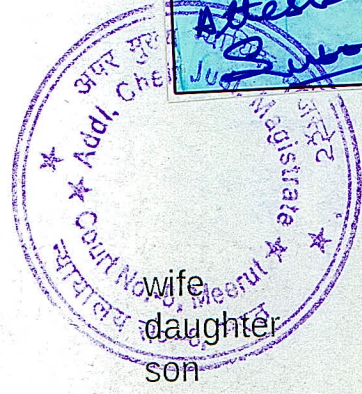
