May kindly see the letters dated <u>13.3.19</u> (flagged 'A' and 'A-1') by which Sri Sanjai Kumar Singh-I, Additional District & Sessions Judge(FTC), Jhansi has submitted his movable and immovable property statement for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15, 2015-16 and 2016-17.

Earlier Sri Singh has submitted his property statements for the years 2010, 2011, 2012 and 2013 vide his letter dated 19.2.15(flag 'B') but they were not on proper proforma, hence a Court's letter dated 23.3.15 (flag 'C') has been sent to the officer to furnish his property statements for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 after mentioning his S.B.A/cs, balance at the end of the financial years etc.

In reply officer has submitted his revised movable and immovable property statement for the financial years 2010-11, 2011-12, 2012-13, 2013-14, 2014-15, 2015-16 and 2016-17 vide his letters dated <u>13.3.19</u> ('A' & 'A-1').

In this connection, it is submitted that as per statement of movable and immovable property for the financial year 2010-11, 2011-12, 2012-13, 2013-14 & 2014-15 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:

- (1) In the financial year 2010-11, Sri Singh 's income from Salary is Rs.7,99,384/- from this amount Rs.2840/- deducted against GIS, Rs.59,503/- against Income Tax, Rs.5,000/- against PPF, Rs.20,000/- against Tax Saving bond, Rs.117146/- against HDFC/ LIC, The balance of his Saving Bank Account(s) enhanced for Rs.3,58,590/- this year against the balance of previous year. As such, total deductions /repayment/ Savings/investment is Rs.5,63,079/-. Thus a sum of Rs.2,36,305/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2010-11.
  - (2) In the financial year 2011-12, Sri Singh 's income from Salary is Rs.14,03,413/from this amount Rs.4800/- deducted against GIS, Rs.2,98,124/- against GPF,
    Rs.2,53,023/- against Income Tax, Rs.10,000/- against PPF, Rs.20,000/- against L
    & T.Bond Tax Saving bond, Rs.2,39,206/- against HDFC/ LIC, The balance of his
    Saving Bank Account(s) enhanced for Rs.3,08,152/- this year against the balance of
    previous year. As such, total deductions /repayment/ Savings/investment is
    Rs.11,33,305/-. Thus a sum of Rs.2,39,145/- was therefore available with him to
    meet out the household expenditure of his family consisting of four members in the
    financial years 2011-12.
  - (3) In the financial year 2012-13, Sri Singh 's income from Salary is Rs.10,18,585/from this amount Rs.4800/- deducted against GIS, Rs.1,05,798/- against GPF,
    Rs.79,326/- against Income Tax, Rs.10,000/- against PPF, Rs.50,000/- against
    HDFC LIC, Rs.2,51,109/- against Insurances (LIC) and Rs.1,00,000/- against FDR.
    As such, total deductions /repayment/ Savings/investment is Rs.5,96,233/-. The
    balance of his Saving Bank Account(s) decreased for Rs.2,57,321/- this year against

the balance of previous year. Thus a sum of Rs.6,79,673/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2012-13.

- (4) In the financial year 2013-14, Sri Singh 's income from Salary is Rs.11,13,833/-from this amount Rs.4800/- deducted against GIS, Rs.87,949/- against GPF, Rs.1,14,502/- against Income Tax, Rs.100,000/- against PPF, Rs.50,000/- against HDFC LIC, Rs.1,86,109/- against Insurances (LIC). The balance of his Saving Bank Account(s) enhanced for Rs.63,014/- this year against the balance of previous year. As such, total deductions /repayment/ Savings/investment is Rs.6,06,374/-. Thus a sum of Rs.5,07,459/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2013-14.
- (5) In the financial year 2014-15, Sri Singh 's income from Salary is Rs.12,42,573/-from this amount Rs.4800/- deducted against GIS, Rs.66,000/- against GPF, Rs.1,10,497/- against Income Tax, Rs.150,000/- against PPF, Rs.50,000/- against HDFC LIC, Rs.1,86,109/- against Insurances (LIC). As such, total deductions /repayment/ Savings/investment is Rs.5,67,406/-. The balance of his Saving Bank Account(s) decreased for Rs.3,05,087/- this year against the balance of previous year. Thus a sum of Rs.9,80,254/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial years 2014-15.
- (6) In the financial year 2015-16, Sri Singh 's income from Salary is Rs.13,54,146/from this amount Rs.4800/- deducted against GIS, Rs.84,860/- against GPF,
  Rs.1,20,500/- against Income Tax, Rs.150,000/- against PPF, Rs.1,86,109/- against
  Insurances (LIC). The balance of his Saving Bank Account(s) enhanced for
  Rs.27,675/- this year against the balance of previous year. As such, total
  deductions /repayment/ Savings/investment is Rs.5,73,944/-. Thus a sum of
  Rs.7,80,202/- was therefore available with him to meet out the household
  expenditure of his family consisting of four members in the financial years 201516.

And as per two years block policy, the property statement for the financial year 2016-17 will be taken up for consideration alongwith property statement for the financial year 2017-18, which will be submitted by the officer in near future, be due in the financial year 2018-19.

The statement of movable and immovable property for the financial year 2010-11, 2011-12 & 2012-13 has been firstly submitted by the officer vide his letter dated 9.2.15(flag 'B') and movable and immovable property for the financial year 2013-14, 2014-15 & 2015-16 has been submitted by the officer vide his letter dated 13.3.19(flag 'A-1'). property statements for the financial years 2010-11 and 2011-12 was due to be submitted in the financial year 2012-13, property statements for the financial years 2012-13 and 2013-14 was due to be

submitted in the financial year 2014-15, and property statements for the financial years 2014-15 and 2015-16 was due to be submitted in the in the financial year 2016-17. As such there is delay in submitting the Property statement for the financial years 2010-11, 2011-12, 2013-14, 2014-15 and 2015-16 from the part of officer for which he has stated that due to transfer he was unable to submit the same in due time and regretted that it will not be repeated in future,

In this connection it is submitted last time Sri Singh had submitted his property statement upto 2009-10, which had already been seen by Hon'ble Mr. Justice Shabihul Hasnain, the then Administrative Judge, Gonda Judgeship which is at flag 'Z' and the said statement at flag 'M'.
