May kindly see the application bearing endorsement No. 26 dated 03.01.11(**placed below**) of Sri Sanjay Kumar Singh, Addl. Chief Judicial Magistrate(Railway), Gonda, along with its enclosures, regarding counting of previous service, rendered by him, with his present service in U.P.Nyayik Sewa for the purpose of pensionary benefits.

Through aforementioned application, Sri Sanjay Kumar Singh has stated that at present he is posted as Addl. Chief Judicial Magistrate(Railway), Gonda. He had first joined the U.P. Nyayik Sewa as Addl. Civil Judge(JD), Ghazipur on 17.06.2006. Prior to joining U.P.Judicial Services, he has worked as Sub-Inspector in Police Department under Government of U.P, from 10.09.2001 till 16.06.2006. He has further stated that there is no interruption between his previous and present services.

In this context it is submitted that earlier also, Sri Sanjay Kumar Singh had requested for counting of previous service with his present service, but through Govt. letter No. 3274(1)/II-4-09-23(12)/07 dated 28.10.2009(**at Flag 'A'**) his plea was rejected.

Now on the basis of provisions contained in 2nd and 3rd para of G.O. No. Sa-3-1671/X-2010-301(09)/2003 dated 16.09.2010(**at Flag 'B'**) and Govt. letter dated 25.04.2011(**at Flag 'C'**) he has once again requested this court to kindly add previous service rendered by him, as Sub-Inspector in Police Department from 10.09.2001 to 16.06.2006, with his present service in U.P. Nyayik Sewa for the purpose of pensionary benefits.

It is further submitted that orders are being passed by the Govt. of U.P in the matter of counting of previous service of Judicial Officers. Therefore it seems proper that aforementioned application of Sri Sanjay Kumar Singh, regarding counting of previous service with present service, may be sent to the Govt. of U.P. for necessary action.

In the above circumstances, if approved by Hon'ble Mr. Justice Ashok Bhushan, a copy of application dated 03.01.2011 of Sri Sanjay Kumar Singh, along with its enclosures, regarding counting of previous service rendered by him with his present service in U.P.Nyayik Sewa, may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow, for obtaining orders of the Government in this matter?
