May kindly see the application dated 03-01-07 of Smt. Sliikha Pathak, Judicial-Magistrate-III, Meant, for grant of medical advance amounting to Rs. 10,00,000/= on account of treatment of Acute myeloid leukaemia-M<sub>3</sub> type at Sharanashilla Cancer Hospital and Research Centre, Delhi, placed below, at folio 'A'.

In her aforesaid application Smt. Pathak has stated that she is suffering from AMK (Acute Myeloid Leukaemia) M<sub>3</sub> and now she had been admitted in Sharanashilla Cancer Hospital and Research Centre, Delhi since 20-12-2006. She has further stated that the treatment of AMK is an expensive affair and it requires a lot of emotional/financial and social support to fight the disease. During the process of treatment, continuous supply of blood and platelets almost on daily basis will be required, apart from the costly medicines and the operations. The derivation of 1 unit of platelets costs more than Rs. 11000/= and requires one healthy donor. She has also stated that Hon'ble Court is also aware of the financial condition of a Judicial Officer who has just started her career.

In view of the aforesaid circumstances Smt. Pathak has requested this Court to release an advance payment of Rs. 10,00,000/= to enable her to undergo required treatment successfully. The chemotherapy treatment will begin

soon and thereafter for sometime she may not be permitted by the doctor, to read and write to avoid infection. She has also furnished an estimate of treatment for Rs. 12,00,000/- likely to be taken from Shrawastha Cancer Hospital and Research Centre, Vasundhara Enclave, Delhi. The estimate of treatment of Shrawastha Cancer Hospital, Delhi is at flap 'X'.

In this connection it may be submitted that in view of G.O. No. 1209/V-6-2004-294/907 T.C. dated 09-08-2004, medical advance upto 75% of estimated expenditure over the treatment so certified by the Medical Superintendent of concerned hospital or head of Medical Institute can be sanctioned by the sanctioning authority of medical reimbursement claim. Smt. Shikha Pathak has applied for Rs. 10,00,000/- for medical advance for treatment of blood cancer. Treatment taken within the state or out of the state for more than Rs. 2,00,000/- the medical reimbursement claim can be sanctioned by the Administrative Department of the Government after advice from Medical Department and approval of Finance Department. As such the medical advance for Rs. 10,00,000/- so applied for by Smt. Shikha Pathak Judicial Magistrate, Meerut may be sanctioned by the Government; If approved by Peonied Registrar
