May kindly see the letters dated 22.08.2008 of the District Judge, Ghaziabad, regarding reimbursement of medical expenses, amounting to Rs.5,52,471=00 and Rs.1,46,610=00 of Smt. Shikha Pathak, Additional Civil Judge, (Jr. Div.), Ghaziabad, incurred in ~~his~~ treatment of accqute myeloid leucaemia- M-3 Type at Dharamsheela Cancer Hospital and Research Center, ~~New~~ Delhi placed at Flag 'A & B'.

It may be recalled that earlier vide office memorandum dated 20.03.2008 of the Government of Uttar Pradesh, Smt. Sheekha Pathak was sanctioned medical advance for Rs.9,00,000=00 (**NINE LACS**) for ~~the~~ <sup>her</sup> treatment taken at Dharamsheela Cancer Hospital and Research Center, New Delhi. The office memorandum dated 20.03.2008 of Government of Uttar Pradesh is being placed at Flag 'C'.

Against the aforesaid Medical Advance, Smt. Sheekha Pathak had submitted two medical reimbursement claims amounting to Rs.5,52,471=00 and Rs.1,46,610=00 for the treatment taken at Dharamsheela Cancer Hospital and Research Center, ~~New~~ Delhi from 28.12.2006 to 07.02.2007 and from 07.03.2007 to 31.03.2007 respectively. The original bill/vouchers and other relevant papers are placed below.

In this connection it may be submitted that under the provisions contained in the Govt. Order No.1209/V-6-2004-294/96, T.C., Dated 09.08.2004, medical reimbursement claim for more than Rs.2,00,000=00 can be sanctioned by the Administrative Department of the Government with the recommendation of Medical Department and ~~with the~~ <sup>with the</sup> consultation of Finance Department of the Government of Uttar Pradesh.

**A** If approved by the Learned Registrar General, medical reimbursement claims amounting to Rs.5,52,471=00 and Rs.1,46,610=00 of Smt. Sheekha Pathak may be sent to the Government of Uttar Pradesh against the Medical Advance, amounting to Rs.9,00,000=00, earlier sanctioned to her vide office memorandum no.728/II-4-08-53(1)/2007, dated 20.03.2008?
