May kindly see the Government letter dated 18.10.2010 regarding medical advance of Smt. Shikha Pathak, Additional Chief Judicial Magistrate-VII, Ghaziabad placed at Flag 'A'.

It may be recalled that Smt. Shikha Pathak, Additional Chief Judicial Magistrate-VII, Ghaziabad had applied for medical advance, amounting to Rs.5,00,000.00 and Rs.10,00,000.00 for the treatment of Leukemia (Blood Cancer) at All India Institute of Medical Science, New Delhi and her applications were forwarded to the Government through Court's letter no.11269/IV-3226/ Admin A-1 Sec., dated 20.07.2010 and Court's letter no.13888/IV-3226/ Admin A-1 Sec., dated 20.07.2010 placed at Flag 'B & B-1'.

It is pertinent to mention here that ^{earlier} Smt. Pathak had also applied for medical advance amounting to Rs.9,00,000.00 for the treatment of Leukemia in the year 2007. ^{and} The ^{Smt Pathak} medical advance was sanctioned to ~~her~~ vide Government memorandum no.728/II-4-08-53(4)/2007, Lucknow, dated 20th march 2008. Smt. Shikha Pathak had submitted her medical reimbursement claim against medical advance amounting to Rs.9,00,000.00 through endorsement no.3457/I, dated 11.10.2010 at Flag at Flag 'C' of the District Judge, Ghaziabad but the letter of Smt. Pathak which is forwarded by the District Judge, Ghaziabad is faint and invisible so the Court's letter no.18463/IV-3226/ Admin A-1 Sec., dated 20.11.2010 ^{was} sent to the District Judge, Ghaziabad for sending clear and visible copy of letter of Smt. Pathak.

In the aforesaid Govt. letter dated 18.10.2010 it is evident that "उल्लेखनीय है कि चिकित्सा विभाग के शासनादेश दिनांक 9.8.04 में दी गयी व्यवस्थानुसार प्रथमवार स्वीकृत अग्रिम के समायोजन के पश्चात ही दूसरा अग्रिम किया जा सकता है। अतएव कृपया प्रथमवार स्वीकृत अग्रिम रु09,00,000/- के समायोजन की कार्यवाही तत्काल कराने का कष्ट करें। उक्त समायोजन के पश्चात ही दूसरे चिकित्सा अग्रिम को स्वीकृत किये जाने पर विचार किया जायेगा।"

If approved by the Learned Registrar General copy of Govt. letter dated 18.10.2010 may be sent to the District Judge, Ghaziabad with the request that the contents of the Government letter dated 18.10.2010 may be communicate to Smt. Shikha Pathak, Additional Chief Judicial Magistrate-VII, Ghaziabad accordingly.
