May kindly see the Government letter dated 14.05.2012 regarding medical reimbursement claim of Late Smt. Shikha Pathak, Ex-Additional Chief Judicial Magistrate, Ghaziabad, amounting to Rs.71,564.00, incurred in the treatment of AML M3 (Replased) for the period from 05.06.2011 to 08.06.2011 at Dharmashilla Hospital & Research Center, Delhi placed at Flag 'A'.

In this connection it may be submitted that Sri Sanjay Kumar Pathak husband of Late Shikha Pathak had earlier submitted two medical reimbursement claims, amounting to Rs.7,46,673.00 & Rs.71,564.00 through his letter dated 20.08.2011(at Flag 'B') against medical advance amounting to Rs.9,00,000.00 sanctioned earlier by the Government through Govt. order dated 20.03.2008 placed at Flag 'C'. After approval of Learned Registrar General the office of this Court had forwarded the said claims to the Government through Court's letter dated 23.12.2011 at Flag 'D'. Now Government has informed through his letter dated 14.05.2012 that through Court's letter dated 23.12.2012 which runs under in verbatim:-

"धनराशि रू07,46,673.00 की प्रतिपूर्ति की स्वीकृति के सम्बन्ध में कार्यवाही शासन स्तर से की जा रही है। चिकित्सा प्रतिपूर्ति सम्बन्धी अन्य दावा रू071,564.00 की प्रतिपूर्ति की स्वीकृति चिकित्सा परिचर्या नियमावली—2001 के प्राविधानों के अन्तर्गत सक्षम स्तर से कराने का कष्ट करें। उक्त धनराशि स्वीकृत होने की दशा में शासन के कार्याक्षय ज्ञाप संख्या 728/2004—08—53(4)—2007 दिनांक 20 मार्य 2008 द्वारा स्वीकृत चिकित्सा अग्निम रूठ 9,00,000.00 के सापेक्ष्य समायोजित की जायेगी। उक्त दावा रू071,564.00 समस्त विल वाउचर्स सहित मूलरूप में वापस किया जा रहा है।"

In this connection it may be submitted that under the provisions contained in Medical Attendant Rules-2011 no.2275/V-6-11-1082-87, dated 20.09.2011 the sanctioning authority for retired Government servant placed below:-

In this connection it may be submitted that under the provisions mentioned above the aforesaid medical reimbursement claim, amounting to Rs.71,564.00 of
