May kindly see the letter-No.663/XV, dated 09.02.2015 of District Judge, Ghaziabad regarding the Medical reimbursement claim of Late Smt. Shikha Pathak Ex Additional Chief Judicial Magistrate, Ghaziabad, at **Flag 'A'**.

By the aforesaid letter, the District Judge, Ghaziabad has submitted that the medical reimbursement claim of Late Smt. Shikha Pathak Ex Additional Chief Judicial Magistrate, Ghaziabad amounting to Rs.7,46,673.00, for the period of treatment from 08.06.2010 to 01.09.2010, incurred in her treatment, out of state at All India Institute of Medical Sciences, New Delhi, has been sanctioned by the Government through the letter No.3344/2-4-2011-53(4)/2007, dated 14.05.2012 of Principal Secretary, Government of Uttar Pradesh, on which the then District Judge has directed to Officer Incharge, "Bill" on 19.05.2012. No action has been taken after order dated 19.05.2012. As a result the sanctioned amount has not been drawn in the financial year of 2012-2013 and the sanction order of the Government remained unutilised.

He has further submitted that he has sent letter 424 Ghaziabad, dated 22.09.2014 to the Principal Secretary (Appointment Section-4), Government of Uttar Pradesh, Lucknow for the revival of the aforesaid unutilised sanction order for drawing the aforesaid amount in the financial year of 2014-2015 and reminder letter No.625, dated 03.01.2015 in this regard has also been sent by the Officer Incharge, District Judge, Ghaziabad.

In reply the Under Secretary, Government of Uttar Pradesh through letter No.103/2-4-2015-53(4)/2017, dated January, 2015 has requested for the submission of original medical reimbursement claim through the Registrar General to the Government.

In these circumstances the District Judge, Ghaziabad has requested to this Hon'ble Court for forwarding the original medical reimbursement claim (228 pages) of Late Smt. Shikha Pathak, the then Additional Chief Judicial Magistrate, Ghaziabad to the Government.

May kindly see the letter-No.659/XV, dated 09.02.2015 of District Judge, Ghaziabad regarding the Medical reimbursement claim amounting to Rs.5,52,471.00 of Late Smt. Shikha Pathak Ex Additional Chief Judicial Magistrate, Ghaziabad, at **Flag 'B'**.

By the aforesaid letter, the District Judge, Ghaziabad has submitted that the medical reimbursement claim of Late Smt. Shikha Pathak Ex Additional Chief Judicial Magistrate, Ghaziabad amounting to Rs.5,52,471.00, for the period of treatment from 28.12.2006 to 07.02.2007, incurred in her treatment, out of state at Dharamshila Cancer Hospital and Research Centre, Delhi, has been sanctioned by the Government through the letter No.511/2-4-2011-53(4)/2007, dated 08.09.2011 of Principal Secretary, Government of Uttar Pradesh, on which the then District Judge has directed to Officer Incharge, "Bill" on 13.10.2011. No action has been taken after order dated 13.10.2011. As a result the sanctioned amount has not been drawn in the financial year of 2011-2012 and the sanction order of the Government remained unutilised.

He has further submitted that he has sent letter 423 Ghaziabad, dated 22.09.2014 to the Principal Secretary (Appointment Section-4), Government of Uttar Pradesh, Lucknow for the revival of the aforesaid unutilised sanction order for drawing the aforesaid amount in the financial year of 2014-2015 and reminder letter No.624, dated 03.01.2015 in this regard has also been sent by the Officer Incharge, District Judge, Ghaziabad

In reply the Under Secretary, Government of Uttar Pradesh through letter No.103/2-4-2015-53(4)/2017, dated January, 2015 has requested for the submission of original medical reimbursement claim through the Registrar General to the Government.

In these circumstances the District Judge, Ghaziabad has requested to this Hon'ble Court for forwarding the original medical reimbursement claim (243 pages) of Late Smt. Shikha Pathak, the then Additional Chief Judicial Magistrate, Ghaziabad to the Government.

It is pertinent to mention here that there is probability of ending of the financial year 2014-2015 by the time the order will be passed by the Government and sent to District Judge, Ghaziabad through Hon' ble High Court for drawing the aforesaid amounts of the aforesaid both claims. Therefore request along with the aforesaid both the claims may be sent to the Government for revising the aforesaid unutilised sanction orders passed by the Government through letter No.3344/2-4-2011-53(4)/2007, dated 14.05.2012 and through letter No.511/2-4-2011-53(4)/2007, dated 08.09.2011 of Principal Secretary, Government of Uttar Pradesh, such that the aforesaid sanctioned amounts of Rs.7,46,673.00 and Rs.5,52,471.00 may be drawn in the financial year 2015-2016

In the facts and circumstances mentioned above, may if deemed fit and proper, the file may kindly be laid before the Learned Registrar General, for his kind perusal and orders to the effect that the aforesaid two medical reimbursement claims, amounting to Rs.7,46,673.00 along with all original bill/vouchers and other relevant papers (228 pages) and amounting to Rs.5,52,471.00 along with all original bill/vouchers and other relevant papers (243 pages) of Late Smt. Shikha Pathak, Ex Additional Chief Judicial Magistrate, Ghaziabad with the aforesaid relevant information may be sent to Sri Dharendra Kumar Upadhyay, Under Secretary, Government of Uttar Pradesh for the revival of the aforesaid unutilised sanction orders passed by the Government through letter No.3344/2-4-2011-53(4)/2007, dated 14.05.2012 and through letter No.511/2-4-2011-53(4)/2007, dated 08.09.2011 of Principal Secretary, Government of Uttar Pradesh, such that the aforesaid sanctioned amounts of Rs.7,46,673.00 and Rs.5,52,471.00 may be drawn in the financial year 2015-2016 ?
