May kindly see the letter dated 21.09.2011, placed at flag 'A', received from Sri Abid Shamim, Additional Chief Judicial Magistrate, Lucknow regarding issuance of 'No Objection Certificate'/Identity Certificate for obtaining Passport.

In his letter (flag 'A'), Sri Abid Shamim has stated that he wishes to apply for a passport for which an Identity Certificate (No Objection Certificate) from the Hon'ble Court is required as per direction in column 20 of the application issued by the Ministry of External Affairs. He has further stated that:-

- 1 There is no possibility of any embarrassing position either for the Government of India or the Government of U.P. due to his abroad visit.
- 2 He has not applied for 'No Objection Certificate' before this, therefore no request of him refused for issue of a 'No objection Certificate' for obtaining Passport.
- 3 He has not visited any foreign country earlier.
- 4 No departmental proceeding has been initiated or proceeding against him.

He has also informed about his dependents and has, therefore, requested for issuance of 'No Objection Certificate' for obtaining Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'B'). As per reports, placed below, no vigilance/departmental enquiry is pending against Sri Abid Shamim. Now, as per orders of the Court, 'No-objection Certificates' are being issued to judicial officers for obtaining Passport.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mr. Justice Abdul Mateen, Administrative Judge, Lucknow, the 'No Objection Certificate' at flag 'C' be issued, in favour of Sri Abid Shamim, Additional Chief Judicial Magistrate, Lucknow for obtaining Passport with the direction that he should take prior permission of the Court before proceeding abroad?
