May kindly see the letters, placed below at flag 'A' & 'A-1', received from Sri Abid Shamim, Additional Chief Judicial Magistrate, Fatehpur, regarding issuance of 'No Objection Certificate' for obtaining an Indian Passport.

In his letters, Sri Abid Shamim has stated that he was granted 'No Objection Certificate' for acquiring Indian Passport, but due to personal reasons, application for obtaining passport could not be preferred before the appropriate authority by him within the stipulated time period of six months. Sri Shamim has also submitted four passport size photographs of himself and Affidavits revealing certain informations as well as for surrendering the original 'No Objection Certificate' granted by the Hon'ble High Court, Allahabad earlier. As per Sri Shamim, 'No Objection Certificate' issued to him earlier, was never used by him. He has requested to re-issue 'No Objection Certificate' for obtaining an Indian Passport.

In this connection, it is submitted that issuance of 'No Objection Certificate' i.e. 'Identity Certificate' on new proforma for obtaining Passport is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'C'). Earlier, as per approval dated 08.02.2012 of Hon'ble Administrative Judge, Lucknow (flagged 'X'), 'No Objection Certificate' dated 14.02.2012 was issued in his favour (office copy is at flag 'B'), but as he has requested for issuance of 'Identity Certificate' due to the reason that he could not apply for passport within the allotted time, his request may be considered. As per reports, placed below, no vigilance/departmental enquiry is pending against Sri Abid Shamim. His request is considerable, as he has submitted required details and papers in this connection.

Under the facts and circumstances, mentioned above, if approved by Hon'ble Mrs. Justice Sunita Agarwal, Administrative Judge, Fatehpur, the 'Identity Certificate' at flag 'D' be issued, in duplicate, in favour of Sri Abid Shamim, Additional Chief Judicial Magistrate, Fatehpur, as requested, for obtaining Passport with the direction that he should complete necessary formalities for obtaining passport within due time now and he should take prior permission of the Court before proceeding abroad?
