Thereafter Sri Samim had again submitted the said claim through letter dated 24.02.2014 of D.J. Fatehpur placed at Flag 'D' but due to some objections the claim was returned to the D.J. Fatehpur through Court's letter dated 04.04.2014 placed at Flag 'E'.



Order no.2275/V-6-11-1082-87, dated 20.09.2011 but now new medical reimbursement rules have been implemented and as such now medical reimbursement claims is to be dealt under the provisions contained in <sup>aforesaid & read with G.O.</sup> Government Order No.474/V-6-14-1082/87 T.C., dated 4<sup>th</sup> March 2014.

In this connection it may be submitted that under the provisions contained in <sup>same provisions of</sup> Government Order No.474/V-6-14-1082/87 T.C., dated 4<sup>th</sup> March 2014 substituted the Medical Attendant Rule-2011 no.2275/V-6-11-1082-87, dated 20.09.2011 the sanctioning authority for Government servant who are in service or retired placed below:-

Amount of claim	Sanctioning Authority
Up to Rs.2,00,000/-	Head of the Office
Above Rs.2,00,000/- upto Rs.5,00,000/-	Head of the Department
Above Rs.5,00,000/- upto Rs.10,00,000/-	Administrative Department in the Govt.

In this connection it may be submitted that under the provisions mentioned above the aforesaid medical reimbursement claim, amounting to Rs.1,00,978.00 of Sri Abid Shamim, Additional Chief Judicial Magistrate, Fatehpur may be sanctioned by District Judge in the capacity of Head of the Office as the claim is less than Rs.2,00,000.00.
