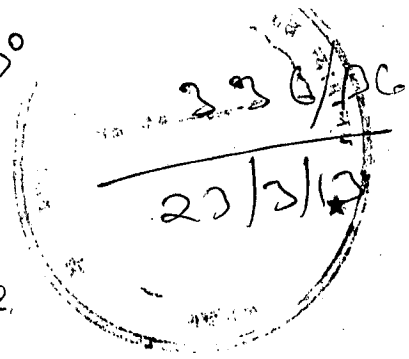



With reference to your letter no.1143/XV dated 26.07.2013, on the above subject, I am directed to return herewith original bill/vouchers and other relevant papers in respect of medical reimbursement claim with the following objections:-

1. Sri Shamim has not submitted medical reimbursement claim in prescribed profoma in **appendix-'C'**.
2. Sri Shamim has not submitted the letter by which he has to be inform to the Head of the office according with point no.11 (b) Medical Attendance Rule-2011, Government notification no.2275/V-6-11-1082-87, dated 20.09.2011.
3. According to Medical Attendance Rule-2011, Government notification no.2275/V-6-11-1082-87, dated 20.09.2011 the medical reimbursement claim is normally is required to be submitted within 3 months but the claim has submitted after a laps of 2 years for which a clarification is required.
4. The aforesaid claim should be preferred on the calculation memo. Payable and non-payable amount is to be mentioned against the column meant for this purpose and the sanction-able amount is to be mentioned by the Chief Medical Officer, Lucknow.

I am, therefore request you kindly to ask Sri Abid Shamim, Additional Chief Judicial Magistrate, Mainpuri to re-submit the aforesaid medical reimbursement claim after removing the objections mentioned above, to this Court, so that necessary action may be taken in the matter.
