May kindly see the letter dated 26.06.2013 of the District Judge, Mainpuri regarding medical reimbursement claim, amounting to Rs.1,00,978.00 of Sri Abid Shamim, Additional Chief Judicial Magistrate, Mainpuri regarding medical reimbursement claim, incurred in Polytrauma with comm. Fracture proximal humerus R with Basal fracture of his mother Smt. Naznin Fatima for the period from 10.07.2011 to 19.07.2011 at Ujala Medical Center, Indra Nagar, Lucknow placed at Flag 'A'.

Through the said letter the D.J. Mainpuri has submitted the claim of Sri Abid Shamim and stated that the claim has been received in this office by the officer concerned with the covering letter of District Judge, Lucknow placed at Flag 'B' for Rs.1,00,978.00. The District Judge has further stated that as the claim is more than Rs.1,00,000.00 as such the claim has been submitted to the Head of the Department.

In this connection it may be submitted that the claim has been checked and found following discrepancies:-

1. Sri Shamim has not submitted medical reimbursement claim in prescribed profoma in **appendix-'C'**.
2. Sri Shamim has not submitted the letter by which he has to be inform to the Head of the office according with point no.11 (b) Medical Attendance Rule-2011, Government notification no.2275/V-6-11-1082-87, dated 20.09.2011.
3. According to Medical Attendance Rule-2011, Government notification no.2275/V-6 11-1082-87, dated 20.09.2011 the medical reimbursement claim is normally is required to be submitted within 3 months but the claim has submitted after a laps of 2 years for which a clarification is required.
4. The aforesaid claim should be preferred on the calculation memc. Payable and non-payable amount is to be mentioned against the column meant for this purpose and the sanction-able amount is to be mentioned by the Chief Medical Officer, Lucknow.

If approved by the Registrar (Budget) the aforesaid medical reimbursement claim may be returned to the District Judge, Mainpuri with the request to direct Sri Abid Shamim; Additional Chief Judicial Magistrate, Mainpuri to submit the claim after removing the objections mentioned above?

If further approved the District Judge, Lucknow with reference to his letter dated 08.07.2013 may be requested to inform that on which date Sri Abid Shamim, the then Additional Chief Judicial Magistrate, Lucknow now posted at Mainpuri Judgeship had submitted the aforesaid claim to his office.
