May kindly see the letter dated 09.11.2012, placed below at flag 'A', received from Sri Niraj Gautam, Additional Civil Judge (Senior Division), Gorakhpur, by which he has requested for grant of permission to purchase immovable property i.e. flat Unit no. V-206, Amrapali Silicon City at plot no. GH-01/A, Sector-76, Noida, District Gautam Budh Nagar measuring 1075 sq. feet, as well as to accept gift amount of Rs. 14,00,000/from his father for purchase of the flat.

In his letter, Sri Gautam has stated that he wants to purchase a flat being constructed in Sector-76 of Noida, District Gautam Budh Nagar by Amrapali Silicon City Pvt. Ltd. of Amrapali Group, costing Rs. 45,55,625/-. For this purchase, Sri Gautam also wants to take gift amount of Rs. 14,00,000/- from his father Dr. Pramod Kumar Singh, who has been retired in June 2010 from the post of General Manager, Central Poultry Region, Patna of Bihar Animal Husbandry Service and get about Rs. 26,00,000/- as his retirement benefits. He has also submitted pointwise details of the proposed transaction, as required under the provisions of this Court's Circular Letter No. 25/ Admin (A) dated 13.07.1998 and has requested for grant of permission to purchase the flate as well as to accept gift amount of Rs. 14,00,000/- from his father for purchase of the flat.

The information regarding transaction of the flat, as required under Courts Circular Letter No. 25/ Admin (A) dated 13.07.1998 as furnished by the officer is given below: -

Rest against purchase price and registration expenses etc. will be paid from his savings of salary in the same bank account no. 1475101000 22249, Andhra Bank, Gorakhpur, in which his salary is deposited, and in which at present, an amount of Rs. 5,70,073/- is in balance (Copy of pass book is at flag 'F). There is a possibility of about a year's time for completion of flat construction and in execution of sale deed of the flat.

It is submitted that as per Rule 24 (1) of U.P. Government Servant's conduct Rule-1956, there appears to be no necessity to take prior permission to purchase an immovable property through a regular and reputed dealer. In the instant case, the officer is going to purchase a flat from a regular and registered company, but as he has applied for grant of prior permission for the same, it may be considered favourably. The matter also involves permission to take gift amount of Rs. 14,00,000/- from his father, who has been retired from the post of General Manager, Central Poultry Region, Patna of Bihar Animal Husbandry Service and has in hand a sufficient money received by him as his retirement benefits i.e. about Rs. 26,00,000/-, papers of which has also submitted by the officer. However, prior permission to accept any gift from a close relative is also appears to be not necessary as per relevant rule of 'gift' i.e. Rule 11 of U.P. Government Servant's conduct Rule-1956. In the instant case, gift transaction is proposed from a blood relative i.e. father of the officer. It is further submitted that rule relating to purchase of immovable property i.e. Rule- 24 (1) of U.P. Government Servant's conduct Rule-1956 and, rule relating to gift i.e. Rule 11 of U.P. Government Servant's conduct Rule-1956 are as follows: -

24 (1)- "No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family;

Provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

- 11. Gifts:- A government servant shall not without previous approval of Government:-
- (a) Accept directly or indirectly on his own behalf or on behalf of any other persons, or (b) Permit any member of his family who is dependent on him, to accept any gift, gratuity or reward from any person other than a close relative.

May, therefore, if approved, the file be laid before Hon'ble Mr. Justice Sanjay Misra for His Lordship's kind perusal and if His Lordship approves, Sri Niraj Gautam, Additional Civil Judge (Senior Division), Gorakhpur be accorded permission to purchase
