May kindly see the letter dated 17.6.14 and 2.3.17 (flagged 'A' and 'A-1') by which Sri Neeraj Gautam, Civil Judge(Sr.Div.), Chandauli has submitted his movable and immovable property statement for the financial years 2012-13 and 2013-14.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2012-13, Sri Gautm's gross income from Salary is Rs.10,77,919/- from this amount Rs.4800/- against GIS, Rs.101861/- against Income Tax, Rs.89530/- against LIC. As such, total deductions/ repayment/Savings/investment is Rs.1,96,191/-. Thus a sum of Rs.8,81,728/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2012-13.

(2) In the financial year 2013-14, Sri Gautm's gross income from Salary is Rs.14,71,133/- from this amount Rs.4800/- against GIS, Rs.1,33,869/- against Income Tax, Rs.89,530/- against LIC, Rs.1,37,417/- towards Housing loan. The balance of his Saving Bank Account(s) enhanced for Rs.1,84,697/- this year from last year's balance. As such, total deductions/ repayment/Savings/investment is Rs.5,50,313/-, Thus a sum of Rs.9,20,820/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2013-14.

It is pertinent to mention here that the wife of the officer Smt. Apurwa Raj income is Rs.1,90,580/- from Private Tuition (in the financial year 2012-13) and Rs.1,05,000/- from Private Tuition (in the financial year 2013-14).

The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer ^{firstly} vide his letter dated 17.6.14 (flagged 'A') which was due to be submitted in third financial years 2014-15. As such there is no delay in submitting the Property statement from the part of officer.

In this connection it is submitted last time Sri Gautam had already submitted his property statement upto financial year 2011-12 which had already been seen by Hon'ble Mr. Justice Dilip Gupta, the then
