May kindly see the letter dated 23.1.2018 (flagged 'A') by which Sri Neeraj Gautam, Civil Judge(Sr.Div.), Chandauli has submitted his movable and immovable property statement for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below.

(1) In the financial year 2014-15, Sri Gautam's gross Salary including allowances is Rs.15,44,358/- from this amount Rs.4800/- is deducted against GIS, Rs.1,30,000/- against Income Tax, Rs.2,22,041/- against repayment of home loan, Rs.1,01,721/- against Insurances. The balance of his Saving Bank Account(s) has enhanced for Rs.2,75,088/- in this year against the balance of previous year. As such, total deductions /repayment/ Savings/investment is Rs.7,33,650/-. Thus a sum of Rs.8,10,708/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2014-15.

(2) In the financial year 2015-16, Sri Gautam's gross Salary including allowances is Rs.17,32,846/- from this amount Rs.1,46,881/- is deducted against CPF, Rs.4800/- against GIS, Rs.1,40,780/- against Income Tax, Rs.2,23,121/- against repayment of home loan, Rs.1,01,721/- against Insurances. The balance of his Saving Bank Account(s) has enhanced for Rs.2,67,512/- in this year against the balance of previous year. As such, total deductions /repayment/ Savings/investment is Rs.8,84,815/-. Thus a sum of Rs.8,48,031/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 23.1.18 (flagged 'A'). The property statements for the financial years 2014-15 and 2015-16 was due to be submitted in third financial years 2016-17 i.e. on or before 31.3.17. As such there is some delay in submitting the aforesaid Property statement from the part of officer.

In this connection it is submitted Sri Gautam had already submitted his property statement upto financial year 2013-14 which had already been seen by Hon'ble Mr. Justice B.K.Narayana, the then Administrative Judge, Chandauli

Judgeship, which is at flag 'Z' and the said statement at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2014-15 and 2015-16 of Sri Neeraj Gautam, Civil Judge(Sr.Div.), Chandauli may kindly be laid before Hon'ble Mr Justice Krishna Singh, Administrative Judge, Chandauli Judgeship for His Lordship's kind perusal and orders ?
