authorities for the provision/requisition of assistants in Admn-H-1 Section. Instead of repeated requests, no additional staff has been provided and the applicant was given an assurance by the authorities concerned that he may get required assistants after the process of new recruitment is being completed. Therefore, the applicant is facing an acute shortage of man-power. In view of the above facts end circumstances, a human error is perceptible and hence this incidence of inordinate delay occurred in processing the letter of Shri Avinash Mishra, for which applicant submits and seeks a personal apology to Your Lordship.

That it is worth to mention here that applicant's staff Shri Dhanraj Singh, Review Officer is looking after the work of two assistants. Due to shortage of x space, files are f piled up everywhere and it is difficult to move and work. Hence, by Sheer inadvertance, the letter dated 10.11.2008 in question of MR. Avinas Mishra has been misplaced in some other file and remained unattended and unprocessed, for which the applicant seeks a pitiful apology to meet the ends of justice.
