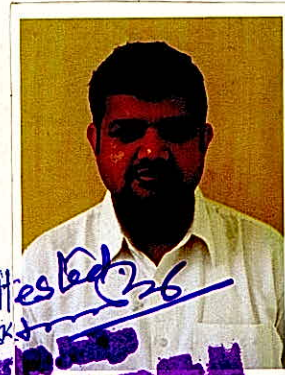

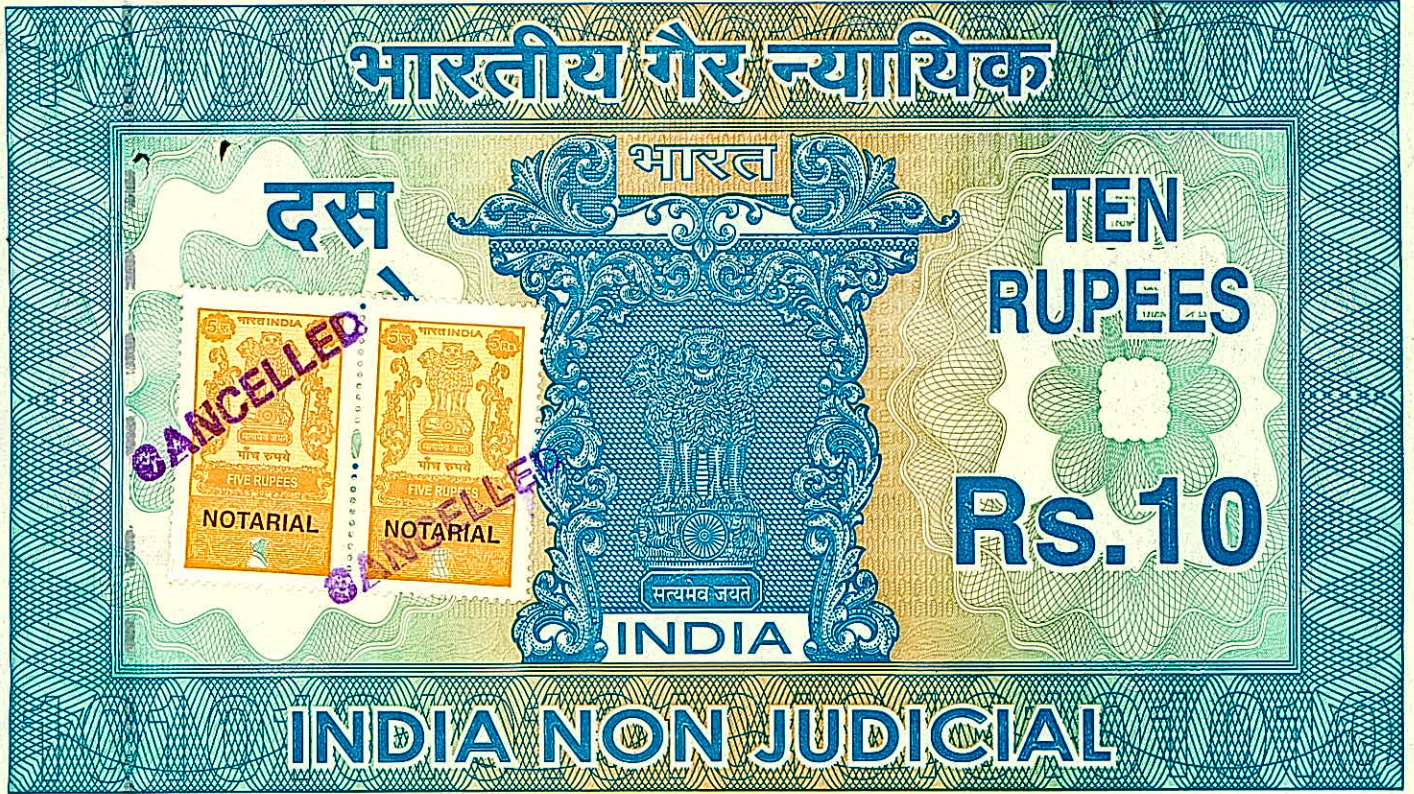

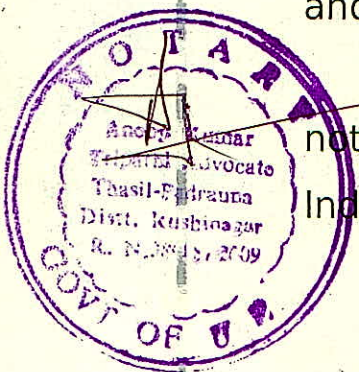

(f) that proceedings in respect of any offence alleged to have not been committed by the applicant are pending before a criminal court in India,

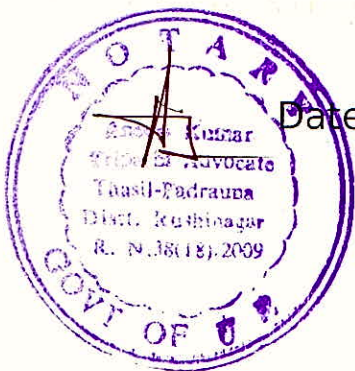

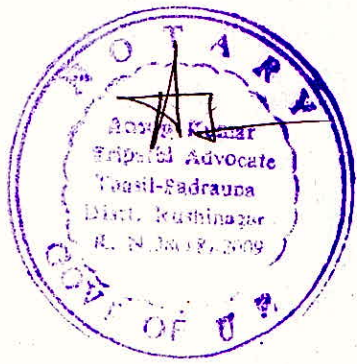
