May kindly see the letters, placed below at flag 'A', & 'A-I' received from Sri Siddharth Singh, Chief Judicial Magistrate, Kushinagar at Padrauna regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by him or any member of his family for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 in the prescribed proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection, it is submitted that earlier Sri Siddharth Singh had submitted his movable & immovable property statements for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 through his letters dated 28-01-2015 (flagged 'A'). Thereafter he was asked to furnish some information vide Court's letters dated 03-04-2015 (flagged 'C').

Now, Sri Siddharth Singh has submitted required informations alongwith required through his letter dated 07-05-2015 (flagged 'A-I').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deduction, savings investment and expenditure made by him are given below.

- (1) In the financial year 2010-11, the income from salary and other allowances is Rs.09,03,153/- and from this amount, Rs.1,72,271/- is deducted against CPF, Rs.1,440/- against GIS, Rs.87,213/- against Income tax, Rs.85,664/- against LIC, Rs.1,02,000/- against mutual fund, Rs.50,000/- against FDR, Rs.40,000/- against NSC and Rs.25,000/- deposited in his PPF accounts in this years. The balance of his savings bank account (s) enhanced for Rs.58,566/- this year. As such, total deductions/ repayment is Rs.06,22,154/-. Thus, a sum of Rs.02,80,999/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year 2010-11.
- (2) In the financial year 2011-12, the income from salary and other allowances is Rs.09,41,072/- and from this amount, Rs.64,876/- is deducted against CPF, Rs.3,480/- against GIS, Rs.87,266/- against

Income tax, Rs.86,347/- against LIC, Rs.1,62,000/- against mutual fund, Rs.35,000/- against NSC and Rs.70,000/- deposited in his PPF accounts in this years. The balance of his savings bank account (s) enhanced for Rs.1,26,093/- this year. As such, total deductions/ repayment is Rs.06,35,062/-. Thus, a sum of Rs.03,06,010/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year 2011-12.

- (3) In the financial year 2012-13, the income from salary and other allowances is Rs.10,43,708/- and from this amount, Rs.55,357/- is deducted against CPF, Rs.4,800/- against GIS, Rs.84,256/- against Income tax, Rs.86,347/- against LIC, Rs.96,000/- against SIP, Rs.35,000/- against NSC and Rs.16,000/- deposited in his PPF accounts in this years. As such, total deductions/ repayment is Rs.03,42,760/-. The balance of his saving bank account (s) is reduced to Rs.46,597/- from its previous year's balance. Thus, a sum of Rs.07,12,545/- was therefore available with him to meet out the household expenditure of his family consisting of three members in whole of the financial year 2012-13.
- (4) In the financial year 2013-14, the income from salary and other allowances is Rs.10,03,368/- and from this amount, Rs.1,28,331/- is deducted against CPF, Rs.4,800/- against GIS, Rs.95,500/- against Income tax, Rs.86,347/- against LIC, Rs.74,000/- against mutual fund, Rs.25,000/- against NSC and Rs.1,00,000/- deposited in his PPF accounts in this years. As such, total deductions/ repayment is Rs.05,13,978/-. The balance of his saving bank account (s) is reduced to Rs.46,423/- from its previous year's balance. Thus, a sum of Rs.06,35,813/- was therefore available with him to meet out the household expenditure of his family consisting of four members in whole of the financial year 2013-14.

In this connection it is submitted that Sri Siddharth Singh has already submitted his property statement of the financial year 2009-10 (statement is at flag 'M') which had already been seen by Hon'ble Mr. Justice V. K. Shukla, the then Administrative Judge, Agra Judgeship at flag 'Z'.

It is further submitted that as as per policy/Court's Circular Letter, the officer has to submit his property statement for the years 2010-11 & 2011-12 in its next financial year i. e. in 2012-13 up to March 2013. He has submitted the same through his letters dated 28-01-2015 as such, there is delay in submitting the same statements. The property statement for the years 2012-13 & 2013-14 in its next financial year i. e. in 2014-15 up to March 2015. He has submitted the same through his letter dated 28-01-2015 and as such, there is delay in submitting the same statements for the years 2012-13 and 2013-14.

May, therefore, if approved, the property statements for the financial years 2010-11, 2011-12 2012-13 and 2013-14 alongwith letter dated 28-01-2015, (flagged 'A',) of Sri Siddharth Singh, Chief Judicial Magistrate, Kushinagar at Padrauna be laid before Hon'ble Mp Justice Vipin Sinha, Administrative Judge, Kushinagar Judgeship for his Lordship's kind perusal and orders?
