May kindly see the letter at flags 'A', received by fax from Smt. Aparna Pandey, Additional Civil Judge (Jr. Div.), Lucknow regarding grant of permission to visit Amsterdam (Holland) and Paris (France) from 12.10.2008 to 20.10.2008.

In her letter, Smt. Aparna Pandey has stated that she is willing to visit Amsterdam (Holland) and Paris (France) from 12.10.2008 to 20.10.2008. She has obtained Passport and the proposed visit is for tourism purpose. She has also submitted that there is no possibility of arising any embarrassing position before Government of India or U.P. due to her visit to the foreign countries and that she has not visited any foreign country earlier. All expenses in this connection would be borne by her from her savings.

She has, therefore, requested that her application may be placed before the Hon'ble Court for granting her permission to visit the countries for tourism purpose, mentioned above.

In this connection, it is submitted that grant of permission to visit abroad is considered in accordance to the G.O.1/3/98-Ka-Prasko/1999 dated 14 June 1999 (flagged 'B'). As per reports, placed below, no vigilance / departmental enquiry is pending against Smt. Aparna Pandey. Recently, she has been issued a 'No-objection Certificate' dated 08.09.2008 (flagged 'C') for obtaining a Passport, which she obtained afterwards as stated. Here, it is worth to mention that his husband is a P.C.S. officer also. Now, as she has requested to grant her permission to visit Amsterdam (Holland) and Paris (France) from 12.10.2008 to 20.10.2008 for the purpose mentioned above, her request may be considered.
