Recently, she has been issued a 'No-objection Certificate' dated 08.09.2008 (flagged 'C') for obtaining a Passport, which she obtained afterwards as stated. Here, it is worth to mention that his husband is a P.C.S. officer also. Now, as she has requested to grant her permission to visit Amsterdam (Holland) and Paris (France) from 12.10.2008 to 20.10.2008 for the purpose mentioned above, her request may be considered.
