May kindly see the letter dated 7.3.15 (at flag 'A') of Smt. Aparna Pandey, Additional Chief Judicial Magistrate, Saharanpur by which she has submitted her movable and immovable property statements for the financial years 2012-13 and 2013-14.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

(1) In the statement of movable and immovable property for the financial year 2012-13, Smt. Pandey's income from Salary and other Sources is Rs.9,27,815/- from this amount, she has paid Rs.88,396/- against CPF, Rs.4800/- against GIS, Rs.72,570/- against Income Tax, Rs.50,000/- against PPF, Rs.38,468/- Insurance. The balance of her Saving Bank Account(s) enhanced for Rs.5,31,908/- this year. As such, total deductions /Savings/investment is Rs.7,86,142/-. Thus a sum of Rs.1,41,673/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2012-13.

(2) In the statement of movable and immovable property for the financial year 2013-14, Smt. Pandey's income from Salary and other Sources is Rs.10,80,987/- from this amount, she has paid Rs.92,895/- against CPF, Rs.4800/- against GIS, Rs.1,03,198/- against Income Tax, Rs.60,000/- against PPF, Rs.33,468/- Insurance. As such, total deductions /Savings/investment is Rs.2,94,361/-. The balance of her Saving Bank Account(s) decreased for Rs.4,16,388/- this year. Thus a sum of Rs.12,03,014/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2013-14.

It is pertinent to mention here that the husband of the officer Sri V.S.Pandey, is a IAS Officer whose annual income is Rs.10 Lacs approx.(in the financial year 2012-13 and 2013-14 each)

The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide her letter dated 7.3.15 (flag 'A') which was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is no delay in submitting the Property statement for the aforesaid periods from the part of the officer.

In this connection, it is submitted that Smt. Pandey has already submitted her property statement upto financial year 2011-12 which was seen by Hon'ble Mr. Justice Ravindra Singh, the Administrative Judge, Saharanpur Judgeship on 18.12.2014 at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2012-13 and 2013-14 of Smt. Aparna Pandey, Additional Chief Judicial Magistrate, Saharanpur may kindly be laid before Hon'ble Mr. Justice Ravindra Singh, Administrative Judge, Saharanpur Judgeship for His Lordship's kind perusal and orders?
