① May kindly see the letter 17.1.17 (flagged 'A') by which Smt. Aparna Pandey, Chief Judicial Magistrate, Bijnor has submitted her movable and immovable property statement for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below.

(i) In the financial year 2014-15, Smt. Pandey's income from Salary and other Sources is Rs.8,66,081/- (Rs.8,17,329/- from Annual gross income from Salary and different arrears and Rs.48,752/- received as interests from Saving Bank & PPF) from this amount Rs.3600/- is deducted against GIS, Rs.42,032/- against Income Tax, Rs.79,364/- against CPF, Rs.70,000/- against PPF and Rs.33,468/- against Insurances. As such, total deductions/ repayment/Savings/investment is Rs.2,28464/-. Thus a sum of Rs.6,37,617/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2014-15.

(ii) In the financial year 2015-16, Smt. Pandey's income from Salary and other Sources is Rs.14,13,873/- (Rs.13,49,411/- from Annual gross income from Salary and different arrears and Rs.64,462/- received as interests from Saving Bank & PPF) from this amount Rs.6,000/- against GIS, Rs.1,53,697/- against Income Tax, Rs.1,09,080/- against CPF, Rs.2,50,000/- against PPF and Rs.33,468/- against Insurances. As such, total deductions/ repayment/Savings/investment is Rs.5,52,245/-. Thus a sum of Rs.8,61,628/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial year 2015-16.

It is pertinent to mention here that the husband of the officer Sri V.S.Pandey is an I.A.S. Officer whose Annual Salary is Rs.11.50/- lacs. (in the financial year 2014-15) and Rs.12.50/- lacs. (in the Financial year 2015-16)

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide her letter dated 17.1.17 (flagged 'A') which was due to be submitted in third financial years 2016-17. As such there is no delay in submitting the Property statement from the part of officer.

In this connection it is submitted last time Smt. Pandey had already submitted her property statement upto financial year 2013-14 which had already
