May kindly see the letter dated 25.3.2019 at flag 'A' by which Smt. Aparna Pandey, Secretary Uttarakhand Human Rights Commission, Dehradun (on deputation) has submitted her property statements for the financial years 2016-17 and 2017-18.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2016-17 and 2017-18 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

- (1) In the financial year 2016-17, Smt. Pandey gross Salary is Rs.12,64,146/- from this amount, she has paid Rs.4800/- against GIS, Rs.1,01,522/- against CPF, Rs.1,32,800/- against Income Tax, Rs.33,468/- against Insurances, Rs.3,00,000/- against PPF. The balance of his Saving Bank Account(s) enhanced for Rs.1,87,438/- this year from last year's balance. As such, total deductions /Savings/investment is Rs.7,60,028/-. Thus a sum of Rs.5,04,118/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial years 2016-17.
- In the financial year 2017-18, Smt. Pandey gross Salary is (2) Rs.11,13,537/- from this amount, she has paid Rs.4400/- against GIS, Rs.106956/- against CPF, Rs.1,21,000/- against Income Tax, Rs.8468/against Insurances, Rs.2,50,000/- against PPF, Rs.60,000/- against ULIP Rs.11,00,000/against FDR. As such, total deductions /Savings/investment is Rs.16,50,824/-The balance of his Saving Bank Account(s) decreased for Rs.11,59081/- this year from last year's balance. As such, total deductions /Savings/investment is Rs.16,50,824/-. Thus a sum of Rs.6,21,794/- was therefore available with her to meet out the household expenditure of her family consisting of four members in the financial years 2017-18.

It is pertinent to mention here that the husband of the officer is I.A.S. Officer his annual Salary is Rs.17 lacs. (approx.) (in the financial year 2016-17) and Rs.19.50/- (approx.) (in the financial year 2017-18).

In this connection, it is submitted that Smt. Pandey has already submitted her property statement up to financial year 2015-16 which was seen by Hon'ble Mr. Justice Suneet Kumar, the then Administrative Judge, Bijnor which is at flag 'Z' and the said statement is at flag 'M'.

The movable and immovable property statements for the financial years 2016-17 and 2017-18 has been submitted by the officer vide her letter dated



25.3.19 (flag 'A') which was due to be submitted in the financial year 2018-19 i.e. on or before 31.3.19. As such, there is no delay in submitting the aforesaid property statements from the part of the officer.
