May kindly see the letter dated 05-06-13, placed below at flag 'A', received from Sri Subodh Singh, Additional Civil Judge (Sr. Div.), Meerut regarding submission of statement of movable property exceeding to value of one month's basic pay and immovable properties acquired/held by his or any member of his family for the financial year 2010-11 & 2011-12 in the prescribed Proforma respectively to this Court for kind perusal and information as required by the Court.

In this connection it is submitted that from perusal of the aforesaid property statement it appears that in the financial year 2010-11 Sri Subodh Singh's total income (from salary and other resources) was Rs.5,68,907/- from this amount his deductions was Rs. 74,615/-, Rs.52,201/- deposited in premium of LIC policies, Rs. 1,00,000/- invest in FDR, Rs. 63,000/- deposited in PPF account Rs. 28,200/- purchase NSC and Rs 66,000/- repayment as car loan. Total deductions and investment is Rs.3,84,016/-. Thus a sum of Rs. 1,84,891/- was therefore available to him to meet out his family (four members) expenditure in whole financial year 2010-11.

In the financial year 2011-12 Sri Subodh Singh's total income (from salary and other resources) was Rs.10,43,028/- from this amount his deductions was Rs.1,68,216/-, Rs.52,201/- deposited in premium of LIC policies, Rs. 1,00,000/- deposited in PPF account, Rs 85,995/- repayment as car loan and Rs. 3,65,980/- deposited in his different bank account. Total deductions and investment is Rs.7,72,392/-. Thus a sum of Rs. 2,70,636/- was therefore available to him to meet out his family (four members) expenditure in whole financial year 2010-11.


In this connection it is submitted that Sri Subodh Singh has already submitted his property statement up to financial years 2009-10 which has already been seen by Hon'ble Mr. Justice S. S. Chauhan, the then Administrative Judge, Haridwar through office note dated 03-08-2010 at flag 'Z'. The said property statement for the financial year 2009-10 is at flag 'M'.


