May kindly see the letters dated 2.1.17 and 21.2.17 (at flag 'A' and 'A-1') of Sri Subodh Singh, Civil Judge(Sr.Div.), Firozabad by which he has submitted his property statements for the financial years 2014-15 and 2015-16.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2014-15 and 2015-16 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the statement of movable and immovable property for the financial year 2014-15, Sri Singh's gross Income from Salary is Rs.10,77,065/- from this amount, he has paid Rs.1,15,966/- against CPF, Rs.5200/- against GIS, Rs.1,11,671/- against Income Tax, Rs.2,50,000/- against PPF, Rs.52,201 against LIC. As such, total deductions /Savings/investment is Rs.5,35,038/-. The balance of his Saving Bank Account(s) decreased for Rs.2,14,063/-. Thus a sum of Rs.7,56,090/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2014-15.

(2) In the statement of movable and immovable property for the financial year 2015-16, Sri Singh's gross Income from Salary is Rs.11,57,849/- from this amount, he has paid Rs.38,793/- against CPF, Rs.4800/- against GIS, Rs.1,21,259/- against Income Tax, Rs.3,00,000/- against PPF, Rs.52,201 against LIC and Rs.1,50,000/- against FDR. The balance of his Saving Bank Account(s) enhanced for Rs.39,343/-. As such, total deductions /Savings/investment is Rs.7,06,396/-. Thus a sum of Rs.4,51,453/- was therefore available with him to meet out the household expenditure of his family consisting of three members in the financial year 2015-16.

The movable and immovable property statement for the financial years 2014-15 and 2015-16 has been submitted by the officer vide his letter dated 2.1.17 (flag 'A'). The Property Statements for the financial years 2014-15 and 2015-16 was due to be submitted in the financial year 2016-17 i.e. on or before 31.3.17. As such there is no delay in submitting the aforesaid Property statement from the part of the officer.

In this connection, it is submitted that Sri Singh has already

submitted his property statement upto financial year 2013-14 which was seen by Hon'ble Mr. Justice Shashi Kant Gupta, the then Administrative Judge, Meerut Judgeship at flag 'Z' and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2014-15 and 2015-16 of Sri Subodh Singh, Civil Judge(Sr.Div.), Firozabad may kindly be laid before Hon'ble Mr. Justice Rajan Roy, Administrative Judge, Firozabad Judgeship for His Lordship's kind perusal and orders ?
