May kindly see the letter placed below at flag 'A', received from Sri Subodh Singh Additional Chief Judicial Magistrate, Meerut by which he has requested for grant of permission to purchase plot measuring 139 sq. yard, situated at village Pilna Sofipur, Pargana-Meerut, Tehsil-Meerut Sadar, Distt. In his letter, Sri Singh has stated that he intends to purchase plot measuring 139 sq. ft., situated at village Pilna Sofipur, Pargana-Meerut, Tehsil-Meerut Sadar, Distt. Meerut in the name of his wife Smt. Anita Singh from Sri Surendra Pal, S/o Sri Hariram, R/o Tanda, Tehsil Sardhana, Distt. Meerut. The price of the said plot has been decided to be Rs. 5500/- per sq. yard, which comes to Rs. 7,64,500/-. He has also submitted pointwise details of the proposed transaction, as required under the provisions of this Court's Circular Letter No. 25/ Admin (A) dated 13.07.1998 and has requested for grant of permission to purchase the plot.

The officer has also submitted that his total gross annual income is approx. Rs. 57,99,059/- from the year 2006 to 2014 and his annual expenses is approx. Rs. 2,80,000/-. He has only one son whose educational expenses comes to Rs. 23,775/-. He has also submitted supporting papers relating to his income from total service period i.e. salary receipts from 2006 to 2014 (starting from flag 'E') and receipts of school fees (starting from flag 'F').

It is further submitted that as per Rule- 24 (1) of U.P. Government Servant's conduct Rule-1956: -

"No Government servant shall, except with the previous knowledge of the appropriate authority acquire or dispose of any immovable property by lease, mortgage, purchase, sale, gift or otherwise, either in his own name or in the name of any member of his family; provided that any such transaction conducted otherwise than through a regular & reputed dealer shall require the previous sanction of the appropriate authority."

Therefore, if approved, the file be laid before Hon'ble Mr. Justice Sudhir Agarwal for His Lordship's kind perusal and if His Lordship approves, Sri Subodh Singh, Additional Chief Judicial Magistrate, Meerut may be accorded permission to purchase Plot measuring 139 sq. yard, situated at village Pilna Sofipur, Pargana-Meerut, Tehsil-Meerut Sadar, Distt. Meerut from Sri Surendra Pal, S/o Sri Hariram, R/o Tanda, Tehsil Sardhana, Distt. Meerut for Rs. 8,18,500/-, as requested, subject to the condition that the relevant papers of the transaction alongwith copy of the sale deed be furnished by him immediately on completion of the transaction?
