May kindly see the letter dated 29.7.13 (flagged 'A') by which Sri Dinesh Kumar Chaurasia, Additional Chief Judicial Magistrate, Unnao has submitted his gross salary and details of deductions regarding statements of Movable and Immovable properties for the financial years 2010-11 and 2011-12~~2010-10 and 2010-11~~, in the prescribed proforma.

Earlier Sri Chaurasia has submitted his property statement for the financial years 2010-11 and 2011-12 vide his letter dated 20.6.13 (flagged 'B') in which he has not mentioned his gross salary and details of deductions then a Court's letter dated 23.7.13 (flagged 'C') was sent to the officer to send a supplementary information in this regard to the Court. In reply officer has submitted a supplementary information in this regard to the Court vide his letter dated 29.7.13 (flagged 'A').

In this connection it is submitted that , Office has made calculation of the aforesaid Property statement and found that from perusal of the aforesaid property statement it appears that in financial years 2010-11 and 2011-12 Sri Chaurasia total income from salary is Rs.18,53,575/- from this amount he has subscribed/deposited total Rs.2,35,339/- in CPF, Rs.2,09,825/- is Income Tax, Rs.5000/- in GIS, Rs.29,691/- (approx.) in Saving Bank Account, Rs.11,000/- in PPF, Rs.1,51,192/- in LIC, Rs.20,000/- in Infra Bond, Rs.31,000/- in NSC and Rs.58,000/- in R.D. Account. The Total deductions and investment is Rs.7,51,047/- . Thus a sum of Rs.11,02,528/- was therefore available to him to meet out his family expenditure in whole year.

In this connection, it is submitted that Sri Chaurasia has already submitted his property statement for the financial year 2009-10 which was seen by Hon'ble Mr. Justice Kalimullah Khan, Administrative Judge, Basti Judgeship on 18.3.13 which is at flag at flag 'Z'. and the said statement is at flag 'M'.

The aforesaid statement has been submitted by the officer vide his letter dated 20.6.13(flagged 'B') but as per Circular letter dated 13.5.04, the property statement for the financial year 2010-11 and 2011-12 is required to be submitted in the financial year 2012-13 i.e.

on or before 31.3.13. There is some delay in submission of aforesaid property statement.

May, if approved, the statements of movable and immovable property for the financial years 2010-11 and 2011-12 of Sri Dinesh Kumar Chaurasia, Additional Chief Judicial Magistrate, Unnao kindly be laid before Hon'ble Mr. Justice Dinesh Gupta, Administrative Judge, Unnao Judgship for kind perusal and orders ?
