Nyayik Sewa through the notification NO 2430/II-4-06-32(1)/2001 T.C dated 26.5.2006 (Dated 26.5.2006) AS such his educational qualification of LL.M ^{may} ~~can~~ be added in his personal biodata / service records with the permission of Government of U.P. Therefore it seems proper that aforesaid application of Sri Dinesh Kumar Chaurasia, ^{the then} Judicial Magistrate I Ind, Ballia now posted as Judicial Magistrate, Basti alongwith its enclosures may be sent to the Government of U.P for orders.
