May Kindly see letter dated 16.09.17 (Flagged at 'A') of Sri Dinesh Kumar Chaurasia, Addl. Chief Judicial Magistrate, Moradabad duly forwarded by the District Judge, Moradabad regarding inclusion of qualification of LL.M. in his service records.

In aforesaid letter, Sri Chaurasia has stated that earlier he had applied for inclusion of LL.M. qualification in his service record through letter dated 28.05.2009 (Flagged at 'B'). In reply to which he was informed to submit attested copy of Degree of LL.M. through this Court's letter no. 12370/IV-3309/Admin.(A) dated 11.10.2009 (Flagged at 'C'), which was submitted by him through his letter dated 29.10.2009 but qualification of LL.M. has not been included in his service record. He has enclosed self attested copies of Marksheet and Degree of LL.M. (Flagged at 'D' & 'E') with his letter dated 16.09.17 and requested the Court to include the same in his service record.

In this connection it may be submitted that Sri Dinesh Kumar Chaurasia had joined U.P. Nyayik Sewa on 15.06.2006. He has mentioned pursuance of LL.M. in his application form of U.P. Nyayik Sewa (Flagged at 'F'). He has completed LL.M. before joining the service from D.D.U. Gorakhpur University, Gorakhpur.

It is further submitted that appointing authority of Judicial Officers is Government of U.P. The qualification of LL.M. may be included in the service records of Sri Dinesh Kumar Chaurasia, Addl. Chief Judicial Magistrate, Moradabad with the permission of Government of U.P., Lucknow. Therefore, it seems proper that aforesaid application of Sri Dinesh Kumar Chaurasia regarding inclusion of LL.M. qualification in his service records may be sent to Government of U.P. for obtaining necessary orders.

Under the fact submitted above, if deemed fit & proper, the file may kindly be laid before Hon'ble Mr. Justice Arvind Kumar Tripathi, Administrative Judge, Moradabad for his Lordship's kind perusal & order to the effect that copy of letter dated 16.09.17 of Sri Dinesh Kumar Chaurasia, attested copy of degree as well as marksheets of LL.M. and attested copy of form of U.P. Nyayik Sewa of Sri Dinesh Kumar Chaurasia may be sent to the Joint Secretary, Appointment Section-4, Government of U.P., Lucknow for obtaining necessary orders of the Government in the matter?
