May kindly see the letter dated 28.6.14 (at flag 'A') of Sri Rakesh Patel, Additional Chief Judicial Magistrate, Jaunpur by which he has submitted his revised property statement for the financial years 2010-11, 2011-12, 2012-13 and also property statement for the financial years 2013-14.

Earlier Sri Patel has submitted his property statement for the financial years 2010-11, 2011-12, 2012-13 vide his letter dated 8.5.14(flag 'B') but in the property statement for the financial year 2010-11 he has shown his incorrect net income i.e. Rs.47,613/- then a Court's letter dated 7.6.14(flag 'C') has been sent to the officer in this regard,

In reply of aforesaid Court's letter, Officer has submitted his revised property statement for the aforesaid period vide his letter dated 28.6.14(flag 'A').

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by him are given below:-

(1) In the financial year 2010-11, Sri Patel's annual income from salary is 5,22,917/- , from this amount, he has paid Rs.1440 against GIS, Rs.29,393/- against CPF, Rs.20,116/- against Income Tax, Rs.61,111/-(with interest) against PPF, Rs.94,000/- against Insurances, Rs.49,400/- against SIPs, Rs.15,000/- against FD, Rs.12,000/- against RD, Rs.20,000/- IDFC Bond. The balance of his Saving Bank Account(s) enhanced for Rs.37,437. As such, total deductions /Savings/investment is Rs.3,39,897/- this year. Thus a sum of Rs.1,83,020- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2010-11.

(2) In the financial year 2011-12, Sri Patel's annual income from salary and arrears is Rs.12,91,168/- , from this amount, he has paid Rs.3680 against GIS, Rs.2,18,801/- against CPF, Rs.1,28,723/- against Income Tax, Rs.66,500/-(with interest) against PPF, Rs.64,000/- against Insurances, Rs.84,000/- against SIPs, Rs.90,000/- against MF, Rs.5,000/- against NSC, Rs.6,000/- against R.D. The balance of his Saving Bank Account(s) enhanced for Rs.30,308. As such, total deductions /Savings/investment is Rs.6,66,704/- this year. Thus a sum of Rs.6,24,464/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2011-12.

(3) In the financial year 2012-13, Sri Patel's annual income from salary is Rs.9,33,549/- , from this amount, he has paid Rs.4800 against GIS, Rs.84,260/- against CPF, Rs.64,969/- against Income Tax, Rs.1,18,499/-(with interest) against PPF, Rs.64,000/- against Insurances, Rs.49,400/- against SIPs, Rs.15,000/- against FD, Rs.12,000/- against RD, Rs.20,000/- IDFC Bond. The balance of his Saving Bank Account(s) enhanced for Rs.37,437. As such, total deductions /Savings/investment is Rs.3,39,897/- this year. Thus a sum of Rs.1,83,020- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2012-13.

(4) In the financial year 2013-14, Sri Patel's Gross income from salary is

Rs.10,56,386/-, from this amount, he has paid Rs.48,00/- against GIS, 99,169/- against CPF, Rs.1,18,628/- against Income Tax, Rs.95,511/- (with interest) against PPF, Rs.44,000/- against Insurances, Rs.12,000/- against R.D. And Rs.1,73,000/- against SIP. The balance of his Saving Bank Account(s) enhanced for Rs.84,958/-. As such, total deductions /Savings/investment is Rs.6,32,958/- this year. Thus a sum of Rs.4,24,320/- was therefore available with him to meet out the household expenditure of his family consisting of four members in the financial year 2013-14.

The movable and immovable property statement for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 has been submitted by the officer vide his letter dated 17.6.14(flag 'B'). The property statement for the financial years 2010-11 and 2011-12 was due to be submitted in the financial year 2012-13 i.e. on or before 31.3.13 and property statement for the financial years 2012-13 and 2013-14 was due to be submitted in the financial year 2014-15 i.e. on or before 31.3.15. As such there is delay in submission of Property statement for the financial years 2010-11 and 2011-12 from the part of the officer.

In this connection, it is submitted that Sri Patel has already submitted his property statement upto 2009-10 which was seen by Hon'ble Mr. Justice Shishsir Kumar, Administrative Judge, Firozabad at flag 'Z' on 16.12.10 and the said statement is at flag 'M'.

May, if approved, the statements of movable and immovable property for the financial years 2010-11, 2011-12, 2012-13 and 2013-14 of Sri Rakesh Patel, Additional Chief Judicial Magistrate, Jaunpur may kindly be laid before Hon'ble Mr. Justice Ashwani Kumar Singh, Administrative Judge, Jaunpur Judgeship for His Lordship's kind perusal and orders ?
