May kindly see the Office note dated 9.4.13( flag 'N') regarding submission of property statement for the financial years 2010-11 and 2011-12 of Smt. Anuradha Pundir, Additional Chief Judicial Magistrate, Etawah which was submitted earlier before Hon'ble Mr. Justice B.K.Narayana, the then Administrative Judge, Etawah but the matter/file was returned back without order. Now, Hon'ble Mr. Justice Abhinava Upadhya is designated as Hon'ble Administrative Judge, Etawah and the matter is likely to be placed before His Lordship's.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2010-11 and 2011-2 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

- (1) In the financial year 2010-11, Smt Pundir's gross income from Salary is Rs.5,18,412/- from this amount, she has paid Rs.21,677/- against CPP, Rs.1260/- against GIS, Rs.18,765/- against Income Tax, Rs.10,000/- against LIC, Rs.10,000/- against PPF, Rs.36,000/- against SIP. The balance of his Saving Bank Account(s) enhanced for Rs.83,319/-(approx.) this year. As such, total deductions /Savings/investment is Rs.1,91,021/-. Thus a sum of Rs.3,27,391/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2010-11.
- (2) In the financial Year 2011-12 Smt. Pundir's gross income from Salary is Rs.11,96,144/- <sup>with arrears and</sup> from this amount she has paid Rs.1,65,934/- against CPP, Rs.840/- against GIS, Rs.1,35,557/- against Income Tax, Rs.1,00,000/- against PPF, Rs.10,000/- against LIC, Rs.43,000/- against SIP and Rs.1,08,000/- against NSC. The balance of his Saving Bank Account(s) enhanced for Rs.6000/- (approx.) this year. As such, total deductions / Savings/ investment is Rs.5,69,331/-. Thus a sum of Rs.6,26,813/- was therefore available with her to meet out the household expenditure of her family consisting of three members in the financial year 2011-12.

It is pertinent to mention here that the husband of the officer is also a Judicial officer whose gross salary is Rs.4,63,112/- (in the financial year 2010-11) and Rs.11,88,400/- (in the financial years 2011-12) <sup>with arrears</sup>.

In this connection it is submitted that, Officer has already submitted her property statement up to financial year 2009-10 which has already been seen by Hon'ble Mr. Justice Sanjay Misra, Administrative Judge, Azamgarh Judgeship on 10.2.11 at flag 'Z' and the said statement at flag 'M'.

Officer has submitted her aforesaid property statement vide her letter dated 23.2.13 which was to be submitted in the financial year 2012-13-i.e. on
