May kindly see the letter dated 12.5.14(flag 'A') received from Smt.Anuradha Pundir, Additional Chief Judicial Magistrate, Etawah regarding submission of statements of movable and immovable properties acquired/held by her or by any member of her family for the financial years 2012-13 and 2013-14 in prescribed proforma to this Court for kind perusal and information as required by the Court's circular letter No.16/IV-h-16/Admin.(A), dated 13.5.2004.

In this connection, it is submitted that as per statement of movable and immovable property for the financial years 2012-13 and 2013-14 of the officer concerned, details of income, deductions, Savings, investment and expenditure made by her are given below:-

(1) In the financial year, 2012-13, Smt. Pundir's income from salary and other sources is Rs.5,38,770/- from this amount, she has paid Rs.5,937/- against New Pension Scheme, Rs.2400/- against GIS, Rs.21,000/- against Income Tax, Rs.1,24,623/- (with interest) against PPF account, Rs.80,004/- against Mutual fund and Rs.33890/- against LIC. The balance of her Saving Bank Account(s)/Post office account decreased for Rs.1,08,505/- in this financial year. As such, total deductions /Savings /investment is Rs.2,67,854/-. Thus a sum of Rs.3,79,421/- was therefore available with her to meet out the household expenditure of her family consisting of four members.

(2) In the financial year, 2013-14, Smt. Pundir's income from salary and other sources is Rs.8,91,010/- from this amount, she has paid Rs.1,39,670/- against New Pension Scheme, Rs.4800/- against GIS, Rs.76,463/- against Income Tax, Rs.1,32,208/- (with interest) against PPF account, Rs.80,004/- against Mutual fund and Rs.33890/- against LIC. The balance of her Saving Bank Account(s)/Post office account enhanced for Rs.2,05,936/- in this financial year. As such, total deductions /Savings /investment is Rs.6,72,971/- <sup>6,72,971/-</sup> ~~6,72,971/-~~. Thus a sum of Rs.2,18,039/- <sup>2,18,039/-</sup> ~~2,01,039/-~~ was therefore available with her to meet out the household expenditure of her family consisting of four members.

It is pertinent to mention here that the husband of the officer Sri Abhay Pratap Singh, is also a Judicial officer posted in the same Judgeship whose annual income is more than Rs.10,00,000/-.

In this connection, it is submitted that Smt. Pundir has already submitted her property statement upto financial year 2011-12 which has already been seen by Hon'ble Mr. Justice Abhinava Upadhyya, Administrative Judge, Etawah Judgeship on 24.5.14 at flag 'Z' and the said statement is at flag 'M'.

The movable and immovable property statement for the financial years 2012-13 and 2013-14 has been submitted by the officer vide her letter dated 12.5.14 (flag 'A') which was due to be submitted in third financial year 2014-

15 i.e. on or before 31.3.2015. As such there is no delay in submission of the aforesaid Property statement from the part of the officer.
